TERMS OF REFERENCE
Procurement to Support the Expansion of the network infrastructure of
the Maldives Correctional Service

1. Background of the assignment:

The UNODC Global Maritime Crime Programme (GMCP), in partnership with UNODC's Global Prison Challenges Programme (GPCP), support United Nations Member States in enhancing the capabilities of prison officers through training and mentoring programmes in accordance to international standards and human rights instruments, including the Nelson Mandela Rules. GMPC/GPCP partnership has reached countries in Eastern Africa and South Asia, developing programmes that include management of high-risk prisoners, dynamic security, incident preparedness and response, and senior management training.

In light of the challenges emerged by the COVID-19 pandemic, UNODC seeks to procure equipment to support the capacity of the Maldives Correctional Service in its efforts to ensure the prisoner's contact with the outside work, including family visits, and court hearings in (a) selected prison(s).
