#### 1. Background of the assignment:

The UNODC Global Maritime Crime Programme (GMCP), in partnership with UNODC's Global Prison Challenges Programme (GPCP), support United Nations Member States in enhancing the capabilities of prison officers through training and mentoring programmes in accordance to international standards and human rights instruments, including the Nelson Mandela Rules. GMPC/GPCP partnership has reached countries in Eastern Africa and South Asia, developing programmes that include management of high-risk prisoners, dynamic security, incident preparedness and response, and senior management training.

UNODC seeks to procure equipment to enhance the capacity of the Maldives Correctional Service at Maafushi prison, the biggest in the country and holding the greatest number of inmates, in their information and communications technology (ICT) arrangements.
