## 3. REQUIREMENTS FOR EXPERIENCE AND QUALIFICATIONS:

# **I. Academic Qualifications:**

Master's degree in the field of Public Finance, Economics or other relevant fields

# II. Years of experience:

- At least 5 years of relevant work experience in conducting research on macroeconomics, public finances, monetary policy, financial markets, and debt instruments.
- Research experience in the areas of public finance, budget review and public expenditure review are required.
- Familiarity with the CSDGs and the 2030 Agenda
- Demonstrated ability to engage in strategic analysis, and in-depth sectoral analysis.

- Excellent writing skills required, as demonstrated by previous high-quality research/analytical reports on relevant topics.
- Ability to lead consultations with senior government officials from ministries of economy and finance, line ministries and other key stakeholders in the field required.
- A specific experience in similar assignment in similar international development contexts is an advantage.
- Previous experience of work in Cambodia or countries of similar context, especially with a development partner or government is a very strong advantage.

#### III. Competencies:

- Capacity to engage with senior decision/ policy makers, and to synthesize and present complex arguments in easily understood terms.
- Ability to work collaboratively with team members by sharing information openly and displaying cultural awareness and sensitivity.

# 4. FINANCIAL PROPOSAL

This is a <u>Lump sum output-based contract</u>. Therefore, the interested offerors are requested to submit <u>Final All-Inclusive Price</u> with cost breakdown

# **5. EVALUATION**

Offerors will be evaluated based on the Cumulative analysis.

- Technical Qualification (100 points) weight; [70%]
- Financial/Price Proposal (100 points) weight; [30%]

A two-stage procedure is utilized in evaluating the proposals, with evaluation of the technical proposal being completed prior to any price proposal being compared. Only the price proposal of the Offerors who passed the minimum technical score of 70% of the obtainable score of 100 points in the technical qualification evaluation will be evaluated.

## 5. 1. Technical qualification evaluation criteria:

The total number of points allocated for the technical qualification component is 100. The technical qualification of the offeror/individual is evaluated based on following technical qualification:

Experience in engaging with senior decision/ policymakers, and ability to synthesize and present complex arguments in easily understood terms. With special emphasis on working with Cambodian institutions and policymakers.	20
Superior written communication skills, with the ability to convey complex development concepts and recommendations (assessed by a sample of work provided)	20
Total Obtainable Score:	100

Only the offeror who have attained a minimum of 70% of total points will be considered as technical qualified offeror.

# 5. 2. Financial/Price Proposal Comparison:

- Only the financial/price proposal of offeror who have attained a minimum of 70% score in the technical evaluation will be considered and evaluated.
- The total number of points allocated for the price component is 100.
- The maximum number of points will be allotted to the lowest price proposal that is opened/evaluated and compared among those technical qualified Offerors who have attained a minimum of 70% score in the technical evaluation. All other price proposals will receive points in inverse proportion to the lowest price. [Lowest Price x 100 / Other Price under Consideration] = Points for Other Offerors' Price Component.

# 5.3. Selection Method and Award Criteria:

The award of the contract should be made to the individual consultant whose offer has been evaluated and determined as:

• Responsive/compliant/acceptable, and

• Having received the highest score out of a pre-determined set of weighted technical and financial criteria specific to the solicitation. The total score for each offeror will be calculated independently by this formula: Total Score = Technical Score x 0.7 + Finance Score x 0.3
