A two-stage procedure is utilized in evaluating the submissions, with evaluation of the technical components being completed prior to any price proposals being opened and compared.

The price proposal will be opened only for submissions that passed the minimum technical score of 70% of the obtainable score of 1000 points in the evaluation of the technical component. The technical component is evaluated on the basis of its responsiveness to the Term of Reference (TOR). Maximum 1000 points will be given to the lowest offer and the other financial proposals will receive the points inversely proportional to their financial offers. i.e. Sf = 1000 x Fm / F, in which Sf is the financial score, Fm is the lowest price and F the price of the submission under consideration.

The weight of technical points is 70% and financial points is 30%.

Submission obtaining the highest weighted points (technical points + financial points) will be selected subject to positive reference checks on the consultant's past performance.

1. BACKGROUND

The 2017 Law on State Compensation Liability, effective from July 1st, 2018 has really become an important legal tool for individuals and organizations to claim state compensation for damage caused by public official violating their rights and legal interests. This also has contributed to raising responsibility of public officials in performing their duties and the quality of the state apparatus operation. Since the Law came into effect in 2018 up to now, the number of cases requested for state compensation that have been accepted for settling is 75 cases, in which 42 cases have been settled with a total amount of compensation to be paid by the State of more than 26 billion VND.

In order to bring the Law to life to protect the right of individual and organizations who have been damaged by a behavior of a public official to receive state compensation, supporting these groups in exercising this right is very important. Point dd Paragraph 1 Article 13 of the Law has provided the right of the damaged person to receive guidance on the procedures for claiming compensation from compensation-managing state authorities and agency directly managing the damage-causing official. The EU Justice and Legal Empowerment Programme (EU JULE), implemented by UNDP and UNICEF together with relevant State agencies, is designed to strengthen the rule of law through a more reliable, trusted and better accessed justice system, and specifically to increase access to justice for women, children and those groups which face the greatest obstacles in using the justice system to invoke their rights, including ethnic minorities and poor people.

The strategic and rights-based approach of the Programme is to address the demand-side and the supply-side constrains in the justice sector by building, in a coherent and coordinated manner, the capacity of Government institutions at both the central and provincial level. Capacity building for legal officers of the Government agencies is a need and is one of critical ways to achieve the Programme's objectives. Training for trainers (TOT) courses are one of focus areas for building key resource persons for capacity building activities in the future, including capacity building for public officials who are responsible for guiding and supporting individuals and organizations to claim for state compensation.

2. OBJECTIVES OF THE ASSIGNMENT

In order to support the State Compensation Department of the Ministry of Justice in implementing the 2017 Law on State Compensation Liability, UNDP seeks to commission 2 national legal consultants to develop training materials for trainers on professional skills of public officials in guiding and supporting individuals and organizations to claim for state compensation.

The training materials will be used by the State Compensation Department to conduct trainings of trainers who then will train public officials of compensation-managing state authorities and state compensation settling agencies to enhance their knowledge and skills in this matter.

3. FINAL PRODUCTS

Two consultants will work in a team and will produce:

A set of training for trainers' materials in English and Vietnamese which will be used for two days training of trainers on professional skills of public officials in guiding and supporting individuals and organizations to claim for state compensation, especially skills in supporting vulnerable groups. The training materials should follow the learner-centered and participatory training methodologies. They should include interactive teaching and learning activities, such as games, role plays, demonstrations, group works, case studies to facilitate active participation of trainees during the training.

The set of training materials includes:

(1) Trainee handbook in Vietnamese must include a general introduction on the learning objectives, targeted users, methodologies, learning programme, and at least 3 modules/lessons. Each module/lesson incorporates a detailed lesson plan, learning objectives, the content and reference materials relevant to the module, presentation slides, self – study questions, case studies, pre and post training evaluation forms.

The content of the handbook must include but is not limited to following modules: (1) legal provisions relating the guidance and support to the damaged individuals and organizations to carry out procedures for claiming state compensation and guidance for application; (2) professional skills in guiding and supporting the damaged individuals and organizations to claim state compensation in three areas: administrative management, criminal proceedings, and judgement execution; (3) professional skills in guiding and supporting vulnerable groups, such as ethnic minorities, poor people, people with disability, to claim state compensation.

- (2) A summary of trainee handbook in English and Vietnamese that includes detailed outline of the handbook, introduction, objectives, targeted trainees, learning methodologies, learning agenda, key contents of each module.
- (3) The trainer guide in Vietnamese has introductory information on objectives, targeted users, teaching methodologies, and guidance and notes for trainers in using the training materials. For each of the modules, there will need detailed lesson plan plus detailed interactive learning activities, such as games, role plays, demonstrations, group works, case studies, accompanying power point presentations, and visual tools such as videos, pictures and other creative tools to engage learners. The trainers' guide should have pre and post training evaluation forms, training report template. For adapting with the crisis situation, such as covid-19 pandemic, the trainers' guide should include a section of instruction for users/trainers on how to conduct online training in case the practice does not allow to organize face to face training.

(4) A summary of the trainer guide in English and Vietnamese that includes detailed outlines of the training materials, introduction of the training materials, objectives, targeted trainers, training methodologies, training programme, key contents of each modules, evaluation forms, training report template.

4. APPROACHES AND METHODOLOGIES

The following approaches should be considered during performing the assignment:

1) Ensuring gender sensitiveness:

Due to the nature of the project and the gender and development approach, gender equality and gender sensitiveness aspects should be mainstreamed in the developed training materials and training delivering

2) Participatory and trainee-centered approaches:

The training materials should be developed to help trainers to perform their tasks more efficiently. A participatory and trainee-centered approaches as well as skill-based training method should be employed and expressed clearly in the training materials

5. SCOPE OF WORK

This assignment will be carried out by two national legal consultants hired by UNDP in consultation with the State Compensation Department of the Ministry of Justice.

Two legal consultants will work together in a team. The scope of work for this assignment is as follows:
