Construction Building of Branch PHCC + Furniture in Sherqat, Sherqat District-Salahdin Governorate.

1. PROJECT BACKGROUND

a. Project description

The objective of the Construction Building of Branch PHCC in Sherqat is to restore basic health services to the population of northern neighborhoods of Sherqat city and surrounding villages. The building is owned and operated by Sherqat Health Sector, Salahdin Health Directorate.

b. Direct and indirect beneficiaries

- <u>Direct beneficiaries:</u> 2 doctors and 10 service employs.
- <u>Indirect beneficiaries:</u> population of around 11,000, people (45% male and 55% female)

c. Impact and how it will be measured (quantitative measures)

Restoration of basic health services resulting in better health in the population of northern rejoin of Sherqat city (Baajah neighborhood, Al-Rashideen neighborhood, Al-Omery Village, Shukran Village) which providing health service for 25 -100 patient per day.

2. LOCATION

The project is located in Sherqat district, Salahdin Governorate.

3. BUILDING/CONSTRUCTION DESCRIPTION

The construction consists of a one-story building, with 9 rooms contains a pharmacy, laboratory, reception hall for patients and 2 WC, The Area of PHC = 270 m2.

4. DESCRIPTION OF THE DAMAGE

The Old Branch PHCC was destroyed totally during the military operations.

5. WORKS ON BRIEF

The rehabilitation work includes civil, sanitary, and electrical works

a. The civil part of the works includes <u>but not limited</u> to site preparation, excavation works, filling works, reinforced concrete for foundation, beams, slabs, masonry works, concrete wit BRC, Gypsum plastering, cement plastering, painting works, Mosaic tile works, Gypsum suspending ceiling, wooden doors, steel doors, PVC windows, main gate, sliding steel door, steel handrail, Septic tank, fence work, garden soil filling, generator sun-shed, Room title board crystal-clear glass as indicated on the BoQ.

- b. The sanitary works includes <u>but not limited</u> to water tank installation, ceramic lavatory pedestal, siphon, mixer taps, drainpipes, sewerage pipes, PPR pipes, eastern & western toilet and water pump as indicated on the BoQ.
- c. The electrical works includes <u>but not limited</u> to main distribution board, sub distribution boards, circuit and power cable, ceiling fan, fluorescent fixture, switches, LED brackets, outdoor lighting, fire detection system, stainless steel water cooler, pipe earth system, electrical water boiler, split unit and Generator 50KVa, transformer 100kva, circuit breaker, galvanized steel pole11m as indicated on the BoQ.
