#### **TERMS OF REFERENCE**

## A. Background/Project Description

Through its national development planning including the National Development Plan 8 (2017-2020) and Nation Development Plan -9 (2020-2025), the Government of Somalia recognizes the importance of mainstreaming gender and human rights, underpinning the importance of a holistic approach towards achieving sustainable peace and development. Gender inequality negatively informs poverty, resilience, economic and social development as well as peace. The continuous neglect of the root-causes of gender inequality, the lack of empowerment and human rights will continue to curtail the sustainable development and peace-building agenda of Somalia.

Changes made so far have focused on the protection of women but have done little to engage women as part of the solution, as agents to develop legislation, policies, strategies, structures, services, with associated budget allocations required to secure an environment where women have equal opportunities and access to fulfil their potential and contribute equally to peace and sustainable development. Part of the challenge results from women and girls who remain uninformed about their potential to make real contributions to the well-being of their communities, families, children and themselves as well as to overall national peace and development.

There is a need to strengthen positive awareness amongst women, girls as well as marginalized communities and to capture these stories and examples of women's contributions to national development and peace. Equally, men and boys need to recognize the important role women already play in sustaining lives and how this can be further strengthened in a complementary manner.

In 2020, the Ministry of Women and Human Rights Development (MOWHRD), in partnership with the Ministry of Planning and Inclusive Economic Development (MOPIED) conducted a national women consultation that reached out to over 10220 women across Somalia. The findings are being feed back into the NDP process and shared through existing women platforms and media channels for a concerted advocacy campaign to ensure compliance to the principles of the Somalia Women's Charter.

The UNDP SDG Implementation Facility for Fragile and Conflict Affected Situations builds on this work by supporting gender mainstreaming with evidence gained through the survey, research on official development assistance allocations to gender equality interventions and training to gender focal points and tr local media to understand the SDG framework.

Against this backdrop UNDP is seeking to engage an international consultant to mentor a group of Somali journalists to conduct research and interviews with key government officials, civil society, implementing partners and beneficiaries and produce an analysis of progress on NPD-8 gender targets/the impact of national planning for women and a summary of recommendations from stakeholders.

## B. Scope of Work

The scope of work is to support and advise a team of 2 local journalists (at least 50% women) to: (a) examine activities and results under the gender component of NDP 8 (2017-2020) with a focus on identifying concrete changes in the lives of Somali women that have come about as a result of NPD-8 and progress toward specific targets, and (b) to produce a narrative report aimed at a nonspecialist audience to explain successes and lessons learned in the implementation of NDP-8, with case studies.

#### **D.** Institutional Arrangements

The international consultant will report to the Portfolio Manager of UNDP Economic Recovery and Institutional Development Portfolio in the UNDP Country Office Somalia. The consultant will work under the dual direct supervision of the UNDP Project Manager of the Gender Equality and Women Empowerment and the Head of Communication Unit in UNDP Country Office.

Payment shall be made in installments based on the achievement of the deliverables. Disbursement of payments will be the responsibility of UNDP (once all the required deliverables have been satisfactory delivered and approved by the Project Manager and certified by the Portfolio Manager).

## E. Duration of the Work

Depending on the date of issuance of the contract, the consultancy is for **60 working days** distributed over 3 months, from October to December 2021. When submitting outputs and requests, the consultant needs to consider a lead time of 3 working days for documents to be reviewed and action initiated.

#### F. Duty Station

The work is home based to be carried out remotely.

## G. Qualifications of the Successful Individual Contractor

#### 1. Academic Qualifications:

Master's degree or equivalent in communication, journalism or social science, development, or related field.

## 2. Years of experience:

- At least 5 years of experience as a reporter or researcher for top-level international media outlets.
- At last, 3 years of experience reporting on development issues in developing countries, including issues affecting women, alongside developing country colleagues.

## 3. Experience:

- Knowledge of gender issues in Somalia and experience working with women in vulnerable situations, particularly in east Africa
- Experience working with journalists in developing country contexts and interviewing women for stories placed in international media.
- Experience producing reports and human-interest stories with UN agencies or international NGOs

## Corporate Competencies

- Demonstrates integrity by modelling the UN's values and ethical standards.
- Advocates and promotes the vision, mission, and strategic goals of UN.
- Displays cultural, gender, religion, race, nationality and age sensitivity and adaptability; and
- Treats all people fairly without favoritism.

## Functional Competencies

- Demonstrated strategic technical and intellectual skills in the substantive area.

## J. EVALUATION

**<u>Combined scoring method</u>**; the qualifications and methodology will be weighted a maximum of 70% and combined with the price offer which will be weighted a maximum of 30%. Technical proposals will be evaluated based on their responsiveness to the Terms of Reference (ToR).

## Evaluation Criteria for Technical Score (Maximum of 70 points)

•	Academic qualifications	10 points
•	Years of relevant experience	40 points
•	Proved record of successfully completion of similar assignments	20 points

Only applicants obtaining a minimum of 49 points (i.e. 70% of the 70 points) in the technical score will be considered for financial evaluation

#### Evaluation Criteria for Financial Score, i.e. Price Offer (maximum 30 points).

The maximum number of points assigned to the financial proposal is allocated to the lowest price proposal. All other proposals receive points in inverse proportion. The formula for the rating of the proposals will be as follows: -

#### **Rating the Technical Proposal (TP)**

TP Rating = (Total score obtained by the offer/maximum obtainable score for the TP) \*100

#### Rating the Financial Proposal (FP)

FP Rating = (lowest priced offer/price of the offer being reviewed) \*100

#### Total Combined Score:

(TP rating) \* Weight of TP. i.e. 70%) +(FP rating) \* (weight of FP, i.e. 30) = Total combined and final rating of the

proposal

Final award will be based on the highest combined score based on 70% technical offer and 30% price weight distribution of technically qualified proposals.
