#### 1) GENERAL BACKGROUND

### **United Nations Capital Development Fund**

UNCDF is the UN's capital investment agency for the world's 46 least developed countries. With its capital mandate and instruments, UNCDF offers "last mile" finance models that unlock public and private resources, especially at the domestic level, to reduce poverty and support local economic development.

UNCDF's financing models work through two channels: financial inclusion that expands the opportunities for individuals, households, and small businesses to participate in the local economy, providing them with the tools they need to climb out of poverty and manage their financial lives; and by showing how localized investments — through fiscal decentralization, innovative municipal finance, and structured project finance — can drive public and private funding that underpins local economic expansion and sustainable development. By strengthening how finance works for poor people at the household, small enterprise, and local infrastructure levels, UNCDF contributes to SDG 1 on eradicating poverty and SDG 17 on the means of implementation. By identifying those market segments where innovative financing models can have transformational impact in helping to reach the last mile and address exclusion and inequalities of access, UNCDF contributes to a number of different SDGs.

Based on this experience UNCDF started in 2017 to expand the scope of its programmatic agenda to go beyond digital finance. Through the "Leaving no one behind in the digital era" strategy, UNCDF is supporting, the emergence of inclusive digital economies. The strategy recognizes that reaching the



full potential of digital financial inclusion in support of the SDGs aligns with the vision of promoting digital economies for the following reasons:

#### Women MSME FinTech Innovation Fund in Cambodia

The United Nations Capital Development Fund (UNCDF) developed the Women MSME FinTech Innovation Fund as part of a regional program for Catalyzing Women's Entrepreneurship and to create gender-responsive entrepreneurial ecosystem in partnership with the United Nations Economic and Social Commission for Asia and the Pacific (UNESCAP) and funded by the Government of Canada through Global Affairs Canada. In Cambodia, SHE Investments has been awarded a grant to support a two-year project to create a bookkeeping app as a tool to support MSMEs by enhancing their business operation digitization and creating digital transaction history for access to formal financing. SHE Investments expects to create the bookkeeping platform and services, register and train 400 women MSMEs to use KOTRA Riel (SHE) bookkeeping app and ensure disbursement of loans to 50 women MSME KOTRA Riel (SHE) bookkeeping app users from partner financial institution within project implementation period till 31 December 2021.

The objective of this consultancy is to support beneficiary verifications for the UNCDF Women MSME FinTech Innovation Fund by conducting Focused Group Discussions (FGDs) or Key Informant Interviews (KIIs).

#### 3) SCOPE OF WORK

Working under the direct supervision of the UNCDF Regional Manager for the Digital Hub for Asia, in close collaboration with UNCDF project partners in Cambodia, the consultant will be responsible for providing high quality technical support to design and implement FGDs/Klls including:
