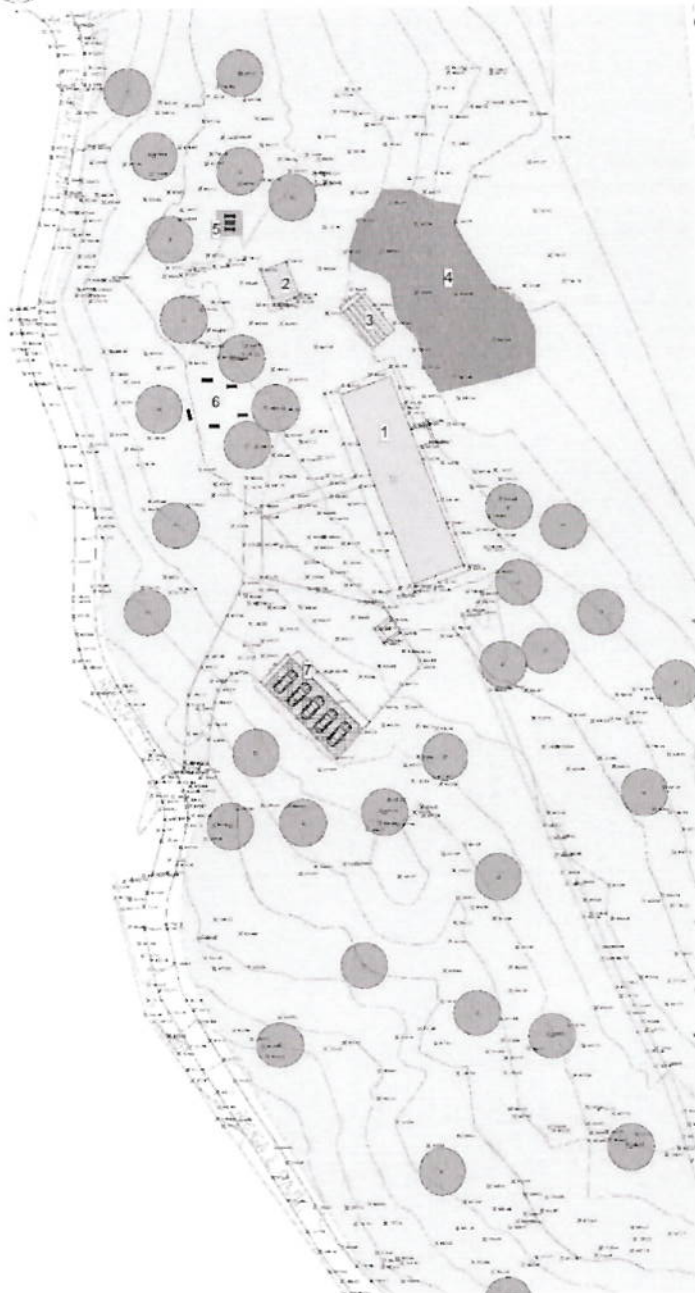

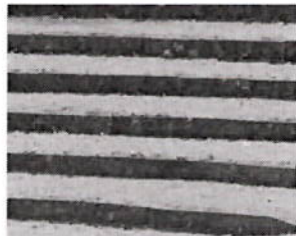
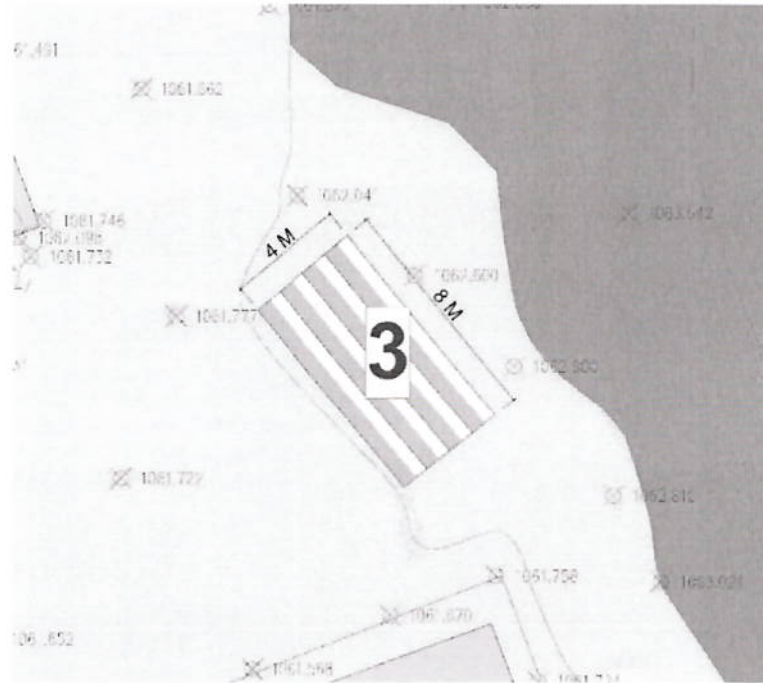

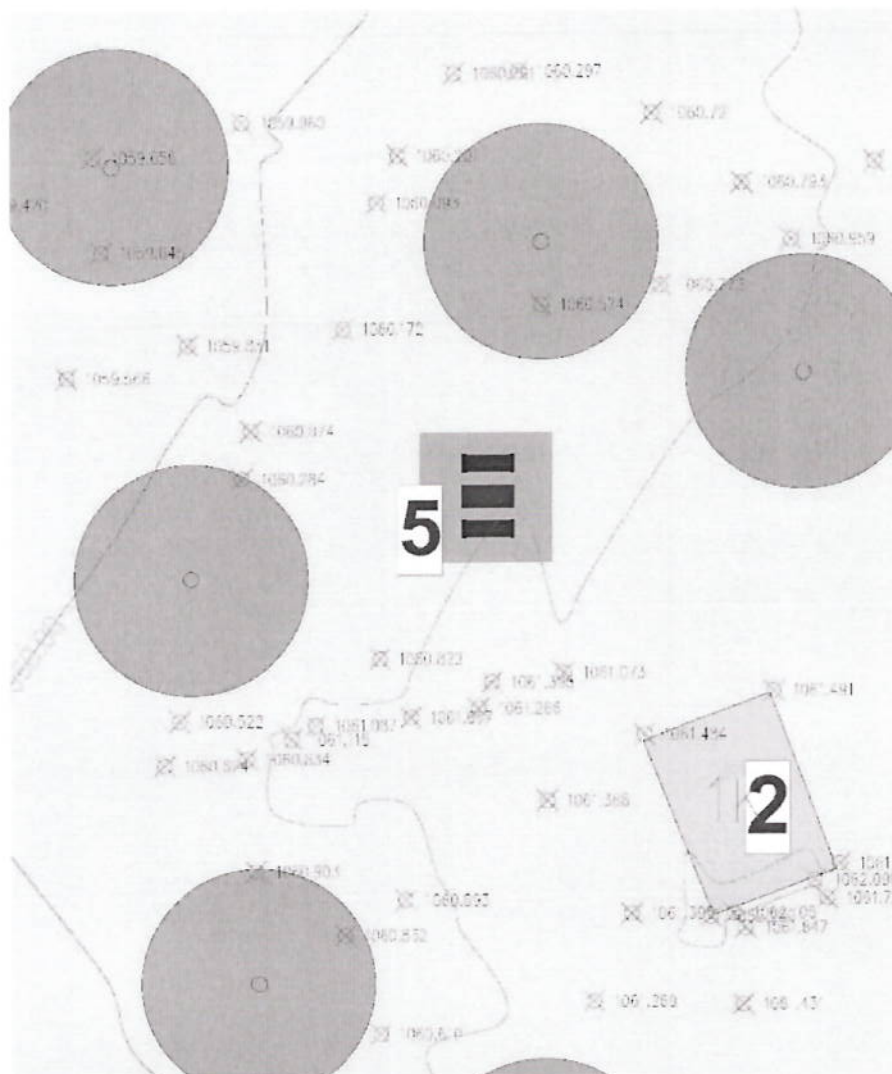

GENERAL PLAN SC 1:500



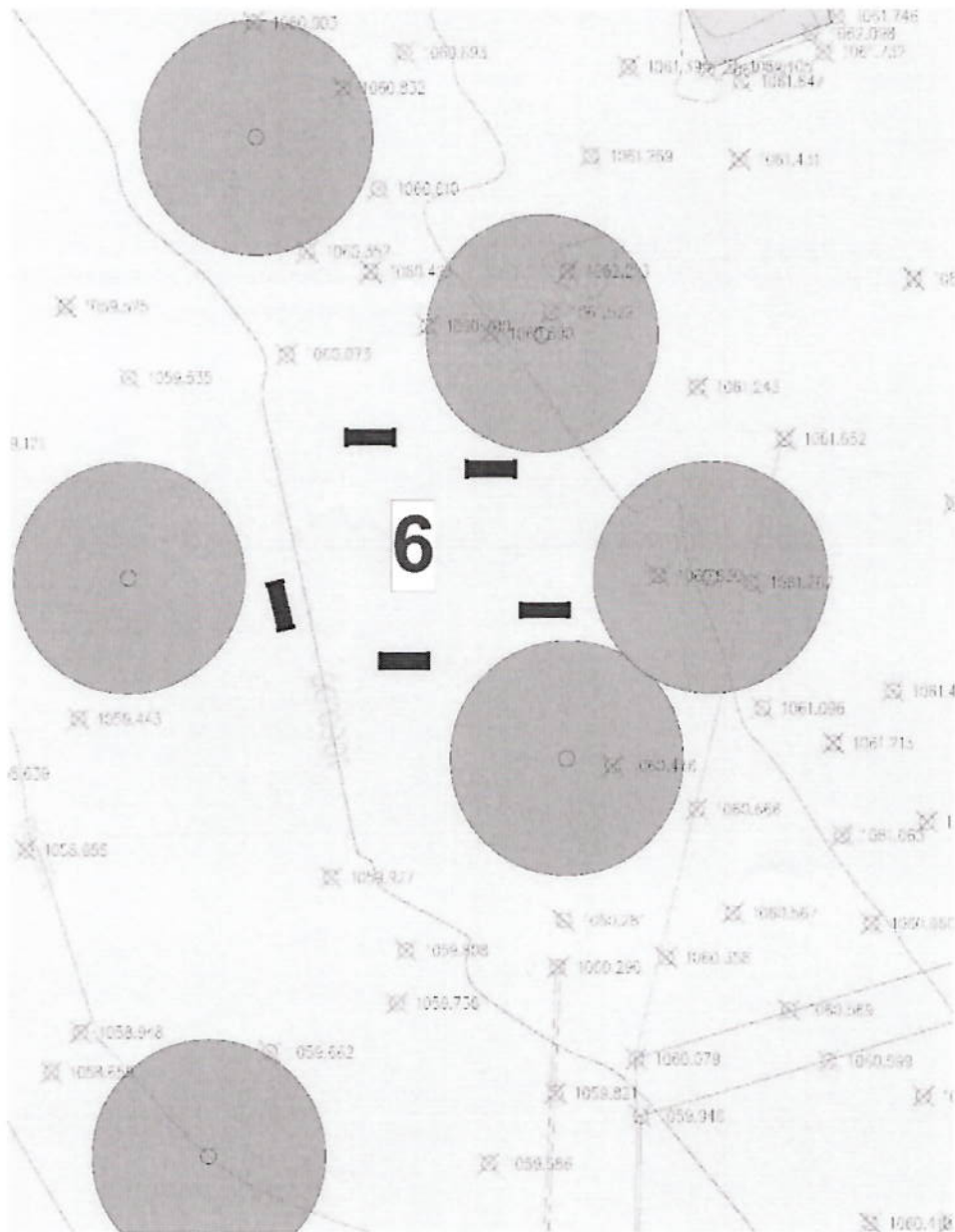

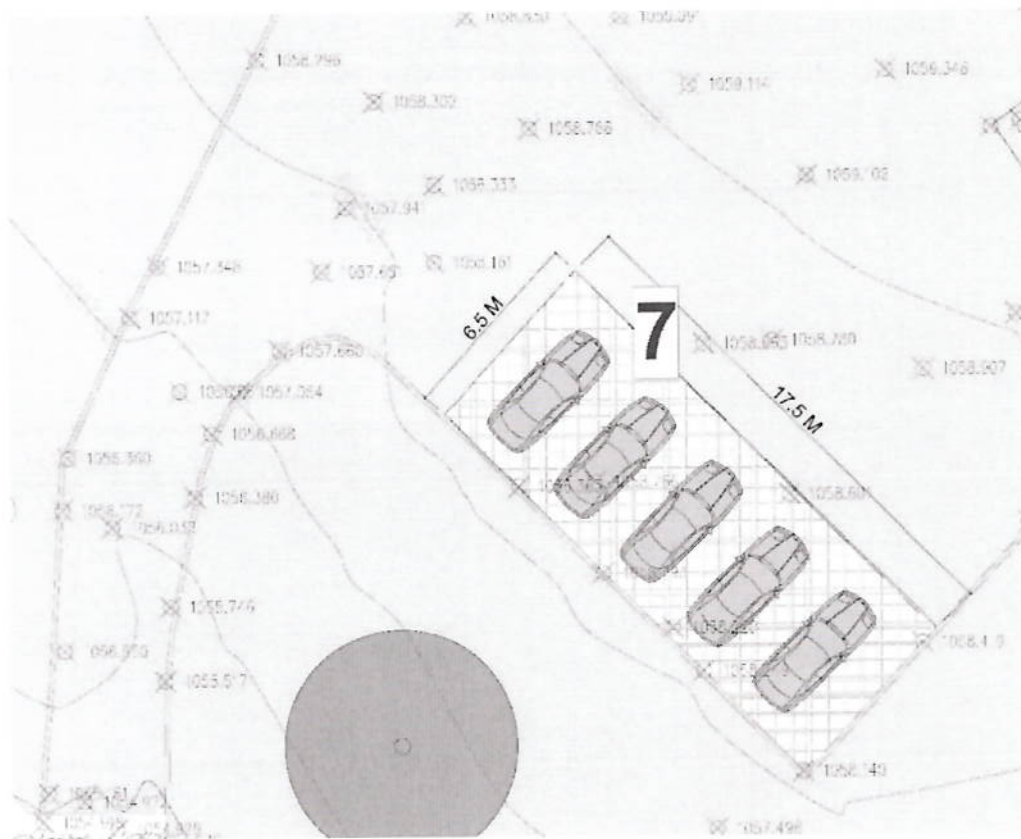
