A two-stage procedure is utilized in evaluating the submissions, with evaluation of the technical components being completed prior to any price proposals being opened and compared.

The price proposal will be opened only for submissions that passed the minimum technical score of 70% of the obtainable score of 1000 points in the evaluation of the technical component. The technical component is evaluated on the basis of its responsiveness to the Term of Reference (TOR). Maximum 1000 points will be given to the lowest offer and the other financial proposals will receive the points inversely proportional to their financial offers. i.e. Sf = 1000 x Fm / F, in which Sf is the financial score, Fm is the lowest price and F the price of the submission under consideration.

The weight of technical points is 70% and financial points is 30%.

Submission obtaining the highest weighted points (technical points + financial points) will be selected subject to positive reference checks on the consultant's past performance.

# **TERMS OF REFERENCE**

#### I. BACKGROUND & PROJECT DESCRIPTION

The International Covenant on Civil and Political Rights (herein referred to as the ICCPR) is a key international human rights treaty. It was adopted by the United Nations' General Assembly in December 1966 and came into force in March 1976. The ICCPR, together with the Universal Declaration of Human rights and the International Covenant on Economic Social and Cultural Rights are considered the International Bill of Human Rights.

Vietnam ratified the ICCPR in 1982 and received the Concluding Observations with recommendations from the Human Rights Committee (HRC) after the 3rd periodic review in March 2019. On 26 September 2019, the Prime Minister of Viet Nam approved the National Action Plan on Enhancing the Effective Implementation of the ICCPR and the HRC's recommendations including several recommendations relating to rights of children, and marriage and family rights (Decision No. 1252/QD-TTg). Although the Appendix of the Decision No. 1252/OD-TTg outlines deadlines and expected results for each activity including activities relating to the rights of children, marriage and family rights, the assessment on whether or not the activities have achieved the results and have any substantive effect in practice requires measurable indicators. Therefore, there is a strong need to develop a set of indicators to monitor the implementation of the ICCPR relating to the right of children, marriage and family. These measurable indicators will help Viet Nam: (i) identify the disaggregated statistical data relating to rights of children and marriage and family rights; and (ii) assess relating agencies' performance in accordance with its international commitments as recommended in the Guidelines for the treaty-specific document to be submitted by State parties under Article 40 of the ICCPR (CCPR/C/2009/1).

The EU Justice and Legal Empowerment Program in Vietnam (the EU JULE Program) funded by the EU and being implemented by UNDP and UNICEF seeks to strengthen the rule of law through a more reliable, trusted and better accessed justice system. One of the key objectives of the EU JULE is to help Viet Nam improve its legal framework in compliance with the international treaties that Viet Nam is a party, including the ICCPR. In 2019 and

2020, under the EU JULE, the overall technical advice documents on the mechanism for monitoring and assessing the implementation the HRC's recommendations and the specific documents focusing on non-discrimination, equality and fair trials were developed respectively (the Reports). A statistical and evidence-based approach is needed to further realize these proposed indicators.

In such context, under the EU JULE Program, UNDP will support the Department of International Law of Ministry of Justice (DIL.MOJ) to commission a team of 2 national consultants and one international consultant to conduct a study on the development of statistical indicators for the implementation of the ICCPR and the HRC's recommendations relating to rights of children, marriage, and family rights (herein referred to as "the Study").

#### **II. OBJECTIVES**

The key objective of the study on indicators for the implementation of the ICCPR and HRC's recommendations relating to right of children, marriage, and family rights is to develop a set of indicators supporting responsible ministries and agencies to implement the HRC's concluding observations on rights of children, marriage, and family rights. Another objective is to ensure that all relevant ministries and agencies are aware of these indicators and understand how to apply and measure them.

#### **III. SCOPE OF WORK**

This assignment will be carried out by a team of consultants including 2 national consultants and 1 international consultant. The successful team is expected to be responsible for the following tasks:

- A proposed set of indicators for measuring the progress and results of the implementation of ICCPR and the HRC's recommendations relating to rights of children, marriage and family rights.

- Identifications of Vietnamese competent authorities in charge of implementing the ICCPR, the HRC's recommendations and Decision No. 1252/QD-TTg, who are the implementing, reporting, monitoring and evaluating partners of the recommended indicators.
- A plan to introduce and train the competent authorities on implementing, reporting, monitoring and evaluating the indicators.
