ANNEX 1: SCHEDULE OF REQUIREMENTS

Context of the requirement:


The “EU4Schools” is an initiative funded by European Union (EU) to accelerate the recovery process in the education sector, after the earthquake of November 26th, 2019 in Albania. The Action aims to deliver rapid assistance to help restore education facilities in order to ensure students loose minimum school and learning days, and to enable the gradual normalization of life of affected population in those municipalities, with education the foremost priority.



“EU4Schools” is targeting educational facilities, including creches, pre-schools, primary education, secondary schools – including VET schools and respective dormitories in municipalities affected by the earthquake, such as: (i) Lezha, (ii) Tirana, (iii) Rrogozhina, (iv) Mirdita (v) Vora, (vi) Shijak, (vii) Durres, (viii) Kruja, (ix) Kurbin, (x) Kamza and (xi) Kavaja.




The overall objective of this Action is to further support local and national governments in reducing social and economic losses, and to accelerate the recovery process through educational facility repairs and reconstruction, which is implemented by UNDP in collaboration with the Albanian Government.

Through this procurement process, UNDP Albania aims at obtaining offers for playground toys and award the contract to the Bidder with the lowest price substantially compliant offer.
