Rehabilitation and furniture for Al-Abzakh Primary school, Nimrud Sub-District, Ninawa Governorate.

1. PROJECT BACKGROUND

a. Project description

Al-Abzakh School is primary schools for boys and Girls, located in Al-Abzakh village, Nimrud sub-District, Al Hamdaniya District, Ninawa Governorate, serving the education process in the Village, rehabilitating these schools will enhance the stability of the community and will encourage the IDP of the village to return to their homes, also provide the opportunity for students and teachers to resume education process in the village.

Direct and indirect beneficiaries

- **Direct beneficiaries:** - 70 boys & girls student expected to rise to 350 when rehabilitated, in addition to 10 teachers and other administration employees.
- **Indirect beneficiaries:** - the citizens of the Village of Al-Abzakh that are estimated **1000** current returnees and expected to rise.
 - Male indirect beneficiaries: **-550**
 - Female indirect beneficiaries**450**

b. Impact and how it will be measured (quantitative measures)

- **Direct Impact:** - can be measured by No. of students who will resume studying in the school and the number of teachers and other administration employees who will resume working again.
