Drilling of a Well in Nargazlya Village-Shaikhan District-Ninawa Governorate

1. PROJECT BACKGROUND

a. Project description

The objective of this project is to Drilling new well including laying pipes network to collect water from this well to the water storage area to provide potable water for Nargazlya Village sub of Shaikhan District. The well will be owned and operated by Dept. of Water, Ninawa Governorate.

b. Direct and indirect beneficiaries

- Direct beneficiaries: - estimated at 1,000 populations (550 males, 450 females).
- Indirect beneficiaries: - 3,000 as population of Nargazlya Village.
