Rehabilitation of Al-Hamdaniya Statistics Division-Ninawa Governorate

1. PROJECT BACKGROUND

a. Project description:

The objective of the project is to provide basic services for the Al-Hamdaniya district and Al-Hamdaniya Statistics Division covered (center Al-Hamdaniya, Bartilla and Al-Nimroud sub-district) sub of Ninewa Gov. And ownership of this building belongs to the Ministry of Planning.

b. Direct and indirect beneficiaries:

- i. Direct beneficiaries: 20 employed (9 male and 11 female) .
- ii. Indirect beneficiaries: 200,000 people (110,000 males and 90,000 female).

c. Impact after completion:

The purpose of the restoration of this building is to restore stability through the restoration of Statistics Division in Al-Hamdaniya region.

2. LOCATION:

The project is located at center Al-Hamdaniya – Ninewa Gov.

3. BUILDING CONSTRUCTION DESCRIPTION:

The Al-Hamdaniya Statistics Division is a two floors construction, with 6 rooms in each floor, bathrooms, and management office. The building is located inside a walled compound, also the guard room is in the yard.

We have partial damage in this building, due to neglect with 35% damage ratio approx. And 60% of the doors have been damaged, we need to rehabilitation the building, sanitation units and pipes are blocked by solid wastes, so would also expect the water supply network and sewerage net also to be damaged.
