The Project “Fostering Participatory Development in Bordering Settlements of Gegharkunik and Vayots Dzor Regions” focuses on reducing the asymmetries of territorial development of Armenia targeting sustainable development and economic integration of bordering areas in Gegharkunik and Vayots Dzor regions. The project will reach out to the vulnerable groups of 34 bordering settlements with a total population of 41981 in two regions through reducing socioeconomic vulnerabilities and facilitating involvement of low-income population in income-generating and production activities, as well as providing access to improved livelihood as a result of rehabilitated community infrastructure. The Project aims at promoting participatory development in target areas facilitating engagement of local population in decision-making at local level and need-based design of local development agenda. The Project pursues the following objectives:

- Objective 1: To foster local participation in development planning and monitoring for bottom-up community development.
- Objective 2: To increase economic activity in the settlements through efficient local production and processing.
- Objective 3: To innovate for improved local production and management.
