Subject: Request for Proposal (RFP No.:1/10/2021-ISA) for -Providing Technical Support for ISA's Investment Series.

Question: Payment Terms: We request you to please provide an indication of the payment terms related the deliverables mentioned in Section 5:

Answer: The payment terms are as follows:

Deliverables	Percent to be paid
On completion of Deliverable 1 to 4	20% of contract amount
On completion of Deliverable 5 to 9	20% of Contract amount
On completion of Deliverable 10 to 13 including 17 & 18	25% of contract amount
On completion of Deliverable 14 to 16	15% of contract amount
On completion of Deliverable 19 & 20 and acceptance of Annual Final and Annual Financial report by ISA Management	20% of contract amount

Question: Request for clarity on Investment Summit/ high-level events at ISA Assembly and COP 27: It is understood from the Terms of Reference that ISA plans to hold an Investment Summit during the next year. High-level events at the ISA Assembly and COP 27 to engage with institutional investors, policy makers, MDBs/DFI. Is some travel foreseen as part of these events? In that case, is PwC required to sponsor the travel for any delegation?

Answer: Any project related mission travel will be reimbursed as per ISA's travel rules.

Question: Request for clarity on conducting research, assessment and analysis of investment scenario in ISA member countries. The Terms of reference mentions the need for conducting background research and in-depth analysis of global investment scenario in ISA member countries. Is the consultant required to conduct the research and analysis for all the ISA member countries or is there a focus on certain sub-set of countries which need to be considered? If yes, request you to please clarify which countries are required to be assessed?

Answer: The analysis and research need to cover all four regions of the ISA.

Question: Request for clarity on facilitating meetings between investors and Energy Ministers of ISA Member Countries: The Terms of Reference mentions that the dialogue facilitation between investors and Energy Ministers of ISA Member Countries needs to be undertaken. Request you to please clarify if ISA would provide the contact details of the Energy Ministers of ISA Member Countries to be reached out to for facilitating meetings between them and the investors?

Answer: ISA will share contact details of ISA's national focal points from member countries.

Question: Child Protection Policy as one of the deliverables in Section 5: Terms of Reference: The Objective and Methodology provided in Section 5: Terms of Reference do not mention anything about the Child Protection Policy; however, it has been proposed as one of the deliverables. Request you to please provide clarity on whether a Child Protection Policy needs to be developed from scratch or some iterations need to be undertaken on a Child Protection Policy that ISA may have developed in the past.

Answer: Not required.

Question: We request an extension of submission deadlines mentioned in Section 3: Bid Data Sheet (Deadline for Submission is 24th November 2021 18:00 Hrs (India time): We request an extension of tender submission deadline by one week from the dates mentioned in the tender owing to administrative difficulty in collating some of the required information.

Answer: The deadline for submission of proposal has been extended till 01 December 2021 (6.00 PM – IST)
