Introduction

The ITSS “Financial Control” has been implemented within the CEC with the UNDP-Moldova support following the need to observe and apply the legal provisions in force as follows:

- Concept of the State Automated Information System “Elections”;
- National Integrity and Anti-corruption Strategy of the Republic of Moldova (NIAS) for 2017–2020;
- CEC Strategic Plan for 2020-2023 (Funding of Political Parties and Electoral Campaigns Oversight Component);
- CEC Regulations on Funding of Political Parties and Electoral Campaigns.

The ITSS “Financial Control” was developed during 2018-2019, while its operation was started in 2020 as a binding financial reporting tool for 2019. It is worth noting that during the ITSS development, the CEC introduced certain changes in the financial reporting forms (following the completion of business analysis activities).

The amendments operated by CEC stem from the amendment of Law No. 294/2007 on Political Parties and of the Electoral Code.

Under these circumstances, whilst piloting the ITSS “Financial Control”, some of the implemented electronic forms were no longer compliant with the forms contained by the:

- Regulation on financing electoral candidates’ campaigns approved by CEC Decision No. 2704 of 17 September 2019, with subsequent amendments;
- Regulation on Funding of Political Parties, approved by CEC Decision No. 4401 of 23 December 2015, with subsequent amendments;
- Regulation on Funding of Initiative Groups to Collect Signatures supporting a Candidate to an Elective Position or to Initiate a Referendum, approved by CEC Decision No. 4176 of 3 September 2020.

Under these circumstances, throughout 2020, additional development services were necessary to tailor the electronic forms as per the new financial reporting methodology, implement new functionalities and ensure functional and corrective maintenance.

Moreover, UNDP-Moldova implemented a Project aimed to digitise the documents related to financial reporting processes of political parties held by the CEC in hard copies. Hence, the reports on funding of political parties during 2015-2018 were subject to digitisation to this end, as well as financial reports related to the following electoral campaigns unrolled during 2016-2019: New Local Elections, Presidential Elections, Parliamentary Elections and Referendum. Overall, as many as 2,264 financial reports were scanned and digitised, comprising 13,240 pages of content.

Nowadays, following the operation of the ITSS “Financial Control”, a number of gaps have been revealed, as well as the need to implement additional functionalities intended to enforce the current legal framework and enhance the IT application ergonomic use. Likewise, CEC intends to adjust the report forms; therefore, it would be needed to consider the possibility to integrate them into the IT System architecture.

This document introduces all ITSS “Financial Control” changing requirements, having displayed a conceptual version of the IT solution, including matters regarding the goal, objectives, principles, core features, functionality and conceptual architecture, functional and non-functional requirements of the IT System.

1. General Information

1.1. Terms used in the Terms of Reference

1.2. References and Legal Issues related to Development Activities

The processes covering the creation, implementation and operation of the necessary ITSS “Financial Control” changes in order to address the current gaps and add new functionalities shall be compliant with the relevant legislative and regulatory acts in effect regarding the CEC activity and development of IT solutions intended for the Moldovan public authorities.

To conceptualise and develop the ITSS "Financial Control" it is appropriate to implement the principles covered by the following international guidelines and recommendations:

1.3. Principles underpinning the ITSS “Financial Control” changes

To ensure attaining the objectives set forth for the IT solution, in the process of ITSS “Financial Control” design, development and implementation full account of the following general principles shall be taken:

- **Principle of lawfulness**, which implies the creation and operation of the IT system in compliance with the national legislation and with the relevant internationally recognized norms and standards;
- **Principle of dividing the architecture by layers**, which means the design and implementation of SAISE components (ITSS “Financial Control” is a SAISE component) in compliance with the interface standards amongst layers;
- **Principle of service-oriented architecture (SOA)**, which means the split of IT system application functionalities into smaller distinct units, called services that can be shared in a network and used together to create applications to implement the IT system business functions;
- **Principle of reliable data**, which provides the input and access of data via authorized and authenticated channels only;
- **Principle of information security**, which implies a proper level of integrity, selectivity, accessibility and effectiveness to secure data against losses, alterations, damages and unauthorized access.
- **Principle of transparency**, which requires the design and implementation according to the modular principle, using transparent standards in the area of information and telecommunication technologies;
- **Principle of expansibility**, which stipulates the possibility to extend and supplement IT Subsystems with new functions or improve the ones already in place;
- **Principle of priority of first person/single centre**, which implies the existence of a senior person assigned with sufficient rights in charge to take decisions and coordinate the activities aimed at creating and operating the IT Subsystems;
- **Principle of scalability**, which implies the provision of a constant performance of an IT solution upon increased amount of data and IT System stress;
- **Principle of simplicity and convenience of use**, which implies the design and implementation of all applications, hardware and software resources available to System users, based exclusively on concept visual, ergonomic and logic principles.

In particular, for the IT Systems architecture, the following major principles shall be complied with:

- providing appropriate security to the IT System aimed at protecting the information and component subsystems against their unauthorized use or disclosure of personal data or of classified information;
- recognizing the information as a valuable asset and ensuring its appropriate management;
- developing and implementing an IT System that grants the possibility to reuse it for other processes or create opportunities to develop new functionalities (including repeated use of SAISE functionalities already in place);
- minimizing the number of various technologies and products that offer the same or similar functionalities as per their purpose (reuse of technologies already implemented by CEC);
- ensuring high-speed processing of service queries addressed to CEC IT Subsystems (authentication, authorisation, logging or notification);
- ensuring disaster recovery ability (safeguarding physical and logical security) as part of the implementation plan.

1.4. Intended Use, Objectives and Tasks of the Terms of Reference

The ITSS “Financial Control” is a CEC IT Subsystem that automates the processes of drafting, sending, checking, approving and publishing all financial reports submitted by political parties/socio-political organisations and electoral candidates to the CEC. The functional requirements of this IT Subsystem meet the provisions of Law No. 101 of 15.05.2008 on the Concept of the State Automated Information System “Elections” (Financial Control function block).

The activities covered by these Terms of Reference shall define the requirements necessary to introduce a number of changes in the ITSS “Financial Control” in order to address/remove the errors and gaps revealed during its operation, as well as to implement additional development functionalities in order to align the IT System with the amendments introduced into the CEC legal framework or to enhance the IT System ergonomics and efficient operation by authorised users.

The selected Developer shall adopt the ITSS “Financial Control” source code (keeping the current architecture and software platform for ITSS “Financial Control” development and operation) and introduce the changes necessary to address/remove the errors and gaps documented in Chapter 3.1 of these Terms of Reference and make adjustments and additional implementations as per the requirements mirrored in Chapter 3.2.

The non-functional requirements specified in Chapter 4 represent the functional requirements, which inspired the ITSS “Financial Control” current version and which observance shall be taken into account throughout the development and work acceptance activities.

2. Description of the ITSS “Financial Control” Current Solution

2.1. Brief Description of ITSS “Financial Control” Functionalities

The ITSS “Financial Control” is a SAISE IT Subsystem, which core objective is to ensure full digitisation of business processes related to financial inspection of activities carried out by political parties of the Republic of Moldova.

Nowadays, the ITSS “Financial Control” implements in full the following business processes:

- User management;
- authentication of authorised Users;
- creating and setting the reporting period;
- filling, checking, signing and sending financial reports;
- creating and receiving summonses;
- configuring the workflows, classifiers and notification events, ceilings, reporting schedules;
- validating the content of financial reports;
- data exchange with external IT Systems;
- generation of specific documents and statistical reports;
- bilingual User Interface: Romanian and English.

At the same time, the System shall ensure:

- drafting financial reports via two alternative methods: 1) drafting financial reports using the User Interface facilities of the ITSS “Financial Control” and 2) drafting financial reports on the basis of pre-defined Excel files;
- validating the content of financial reports received, checking whether all required data have been filled, checking compliance with specific constraints regarding the report content values and the display of messages on detected errors, and showing all report content gaps;
- drafting summonses following the financial inspection results and attaching Minutes;
- importing data from standard files in XML and pre-defined Excel format;
- implementing the electronic signature mechanism to authenticate Users via the Government service MPass and signing the reports and annexes thereto via the Government service MSign;
- integration with interoperability platform MConnect to exchange data with external IT Systems in order to validate the content of financial reports received (for example: SRP – validation of IDNP, SRLE – validation of IDNO);
- extensive logging of business events related to the ITSS “Financial Control” operation;
- printing out the filled and accepted reports, as well as the content of other electronic forms drafted under the ITSS “Financial Control” and their downloading in Excel, PDF, WORD, XML and CSV format;
- automatic publication of depersonalised public data on the CEC Web page, which were produced under the ITSS “Financial Control” business processes;
- uploading and processing historical data;

- delivering public operative data via the interactive map;
- notifying the Users on business events related to their role assigned under the ITSS “Financial Control” ;
- generation and analysis of final aggregated statistics, which are available via the heading "Statistical reports".

Moreover, the ITSS “Financial Control” shall automate a number of inspections of report contents, which were drafted and sent by political actors as follows:

- checking if the financial report mandatory fields have been filled;
- checking if the financial report mandatory fields have been filled with the appropriate types of data;
- checking the area of admissible values for the financial report data fields in compliance with the System of metadata of the IT System;
- checking the existence and admissibility of using the natural person data mirrored in the financial report;
- checking the membership fees of political parties so that a natural person does not pay membership fees to several political parties simultaneously;
- checking the annual amount paid by a natural person to a political party/electoral candidate so that it does not exceed the maximum amount allowed by the legislation in force;
- checking the admissibility of using the legal person data in the financial report content.
- other relevant automatic verifications.

2.2. ITSS “Financial Control” Architecture

The ITSS “Financial Control” is a WEB-based IT solution, accessible via a widely used Internet browser (MS Internet Explorer/MS Edge, Mozilla FireFox, Opera, Google Chrome or Safari) implemented on the basis of a service-oriented architecture (SOA) to interact with the CEC IT Subsystems and external IT Systems.

The ITSS “Financial Control” is based on a client-server architecture of three layers (that excludes any direct application-database interaction), involving cutting-edge WEB technologies. To ensure an appropriate level of information security, the client-server interaction shall be provided via secured connections (via VPN channels and TLS/SSL sessions).

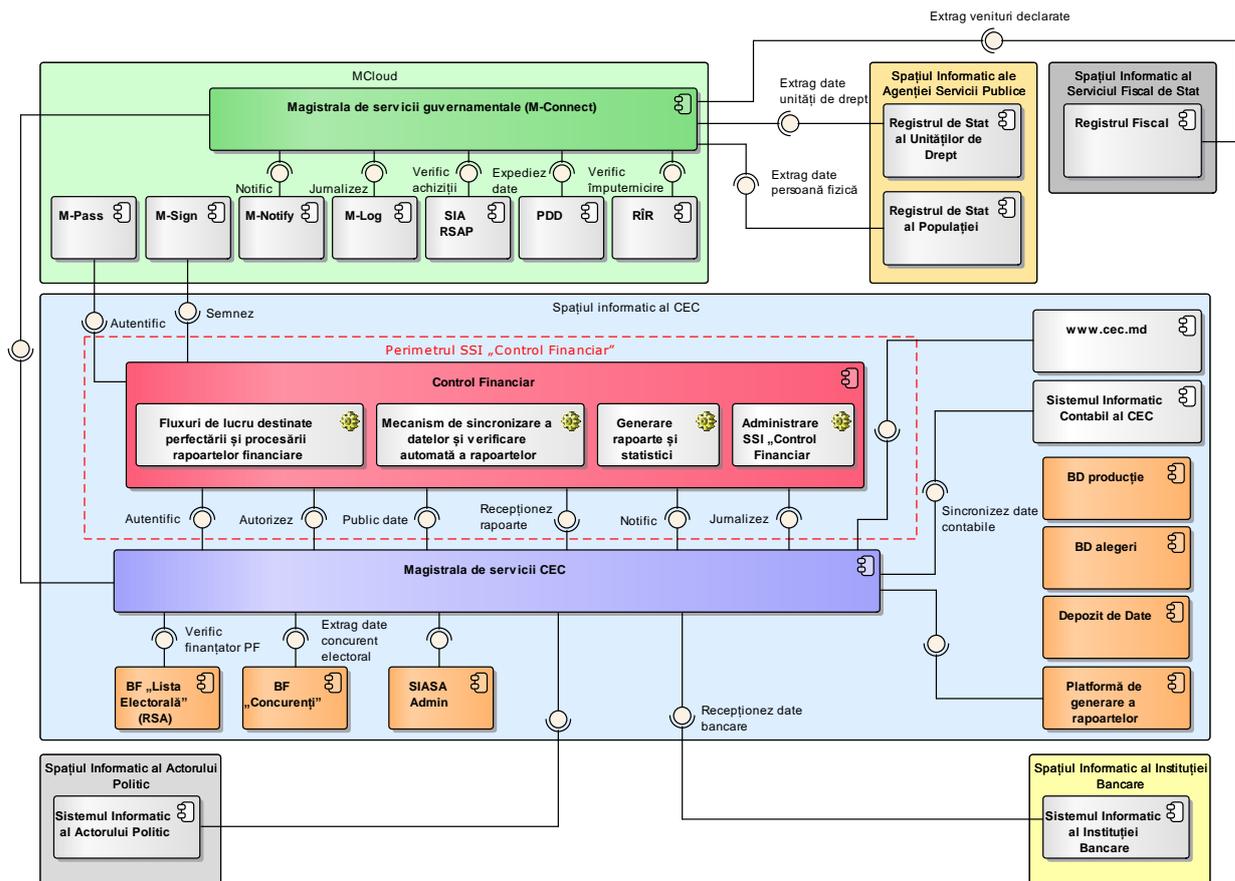


Figure 2.1. ITSS “Financial Control” Architecture.

The interaction of all ITSS actors and hubs is displayed in Figure 2.1. As shown in Figure 2.1, the resource pooling solution to ensure the ITSS “Financial Control” functionality consists of six distinct categories of hubs:

- **CEC Data Centre** – the CEC ICT infrastructure that hosts the ITSS “Financial Control” and where a range of ITSS have been installed to interact with the ITSS “Financial Control”. The changes covered by these Terms of Reference shall apply only to functional blocks fenced with an interrupted red line;
- **M-Cloud** – the ICT infrastructure of the government common technology platform that makes up the government cloud (*MCloud*), which hosts all IT Systems the ITSS “Financial Control” will interact with or use their services;
- **PSA Data Centre** – the ICT Infrastructure of the Public Services Agency hosting the State Register of Legal Entities and the State Register of Population. The ITSS “Financial Control” shall integrate with this IT System via the interoperability platform MConnect;

- **STS Data Centre** – the ICT Infrastructure of the State Tax Service hosting the Tax Register, representing an IT System that provides primary data to the ITSS “Financial Control” aimed to receive the information on income of people financing political actors and crosscheck the amount allocated to finance a political party and the actually declared income of the party financier;
- **Banking Institutions Data Centres** – the ICT Infrastructure of banking institutions where the electoral candidates and political parties hold their settlement accounts, which turnover shall be monitored throughout the period of elections. In case of Treasury accounts (funding of political parties from the State Budget), monitoring shall be carried out over the whole period of political party financing.
- **Client computers** – computers from where Users (depending on their assigned rights and roles) will access the ITSS “Financial Control” functionalities.

Client computers shall use the most popular Internet browsers as client application to access and use the ITSS “Financial Control”. The interface and functionalities delivered to each User depend on his/her assigned rights and roles.

To implement a number of functionalities, the ITSS “Financial Control” shall use a range of services provided by SAISE ITSS as follows:

1. **WEB Service Authenticate** is provided by SAISE Admin to implement a universal and centralised mechanism to authenticate SAISE Users.

2. **WEB Service Authorise** is provided by SAISE Admin to implement a universal and centralised mechanism to authorise the Users (delivering functionalities and data accessible to them), regardless of the SAISE application used.
3. **WEB Service Notify** is provided by SAISE Admin to implement a universal and centralised mechanism to notify SAISE Users, regardless of the SAISE application used.
4. **WEB Service Log** is provided by SAISE Admin to implement a universal and centralised mechanism to log the business events generated by authorised Users within the used SAISE applications.
5. **WEB Service Check the PF financier** is provided by the SRV to retrieve identification data of natural persons financing electoral candidates and political parties.
6. **WEB Service Retrieve data on electoral candidates** is provided by SAISE “Competitors” FB to retrieve data regarding the registration of political parties and electoral candidates.
7. **WEB Service Public data** is provided by CEC official WEB page (<http://www.cec.md>) to display public data produced under the business processes of the ITSS “Financial Control” .

The ITSS “Financial Control” will interact with a number of external IT Systems via the interoperability platform MConnect. The following services displayed by external IT Systems will be used to this end:

1. **WEB Service Authenticate** that interacts with platform service MPass used to implement authentication procedures for CEC external Users via electronic signature.
2. **WEB Service Sign** that interacts with platform service MSign intended to apply and validate electronic signatures, including mobile signatures.
3. **WEB Service Log** that interacts with platform service MLog intended to log with legal value the sensitive business events of the ITSS “Financial Control”.
4. **WEB Service Notify** that interacts with platform service MNotify intended to implement notification processes for CEC external actors operating the ITSS “Financial Control”.
5. **WEB Service Check procurement** that interacts with AIS SRPP (State Register of Public Procurement) to check if the legal persons funding the political parties/electoral candidates have got any public procurement contract.
6. **WEB Service Send data** that interacts with the Government Open Data Portal (<http://date.gov.md>) to publish the set of public data produced under the business processes of the ITSS “Financial Control”.
7. **WEB Service Check power** that interacts with the Register of Representation Powers (MPower) to check the Users’ powers to carry out certain actions under the ITSS “Financial Control” (for example: checking power of a person to report and affix Electronic Signature on reports sent to CEC).
8. **WEB Service Retrieve data on economic operators**, which implements the interaction with the State Register of Legal Entities to receive registration data of economic operators funding the political parties and electoral candidates.
9. **WEB Service Retrieve declared income**, which implements the interaction with the Tax Register to receive data on declared income by natural persons funding the political parties and electoral candidates.

The ITSS “Financial Control” shall display two interfaces for interacting with external IT Systems intended for CEC activity processes as follows:

1. **WEB Service Synchronise accounting data** displayed by the ITSS “Financial Control” to interact with CEC Accounting IT System to synchronise the payments related to political party financing from the National Public Budget.
1. **WEB Service Receive bank data** displayed by the ITSS “Financial Control” to interact with banking IT Systems to synchronise data on account turnover of electoral candidates and political parties.
2. **WEB Service Receive Reports** displayed to IT Systems of political actors to receive automatically financial reports with no need to resort to User Interface facilities of the ITSS “Financial Control”.

3. Functional Requirements for the ITSS “Financial Control” New Version

3.1 Functional Requirements to Remove the ITSS “Financial Control” Current Errors

A range of gaps and errors have been detected during the ITSS “Financial Control” operation that shall be addressed to ensure compliance of the financial reporting process with the regulatory framework in force, as well as to enhance the IT System ergonomics and friendliness.

The ITSS “Financial Control” current gaps and errors are displayed in Table 3.1, being classified depending on their impact as follows:

- **Low** – are typical for the functionalities that are not critical for the IT System smooth operation and for the authorised Users’ job duties. Nonetheless, their removal would have a positive effect on the IT System Users’ experience;
- **Medium** – represent the functionalities required for the IT System smooth operation and for the authorised Users’ job duties, and may have an impact on the authorised Users’ experience in the process of IT System operation;
- **High** – represent the functionalities that are critical for the IT System smooth operation, are frequently required by the IT System authorised Users, and may have a significant impact on the authorised Users’ experience in the process of the ITSS “Financial Control” operation.

The Developer is expected to address all the mentioned gaps and errors prior to implementing new functionalities and adjusting the current functionalities.

6. Implementation Stages of the ITSS “Financial Control” New Version

The Action Plan intended to remedy errors and non-compliances detected and implement new functionalities under the ITSS “Financial Control” is displayed in Table 6.1. Pursuant to the Action Plan, the deadlines for carrying out the Project activities are as follows:
