#### **BACKGROUND**

The United Nations Development Programme (UNDP) supports Jordan to achieve sustainable development that leads to transformational change in service-centered institutions and bring about real improvements in people's lives. UNDP employs a participatory approach to ensure mutual ownership is gained int the design and implementation of policy and programming to guarantee addressing the development challenges that affect the country. UNDP also ensures that considerations such as gender equality, private sector engagement, environmental sustainability, and innovation are addressed, while aligning local demand driven development solutions to the 2030 Agenda.

UNDP and the European Union collaborate in improving public sector's transparency, accountability, and responsiveness to citizens' needs in Jordan. The European Union awarded funds to the United Nations Development Programme (UNDP) to implement the programme "Decentralization, Accountability and Integrity at Local Level Programme (DAILL) in Jordan". A four-year initiative is currently supporting the decentralisation reforms and SDG16 "Peace, justice and strong institutions" implementation in the Kingdom, in line with the policy priorities of the Government of Jordan in the National Renaissance Plan.

DAILL seeks to institutionalise citizen participation in planning as well as to holding the authorities and public officials accountable for their actions and omissions in line with the recommendations of previous evaluation studies. the Programme's implementation will be fundamentally focused on strengthening the administrative and

downwards accountability in Jordan. The role of elected councils and the relationship between citizens and public administration throughout the planning/budget cycle will be enhanced. Transparency will be strengthened through participatory planning processes for both, integrated territorial development plans (governorates and municipalities) and sectoral plans (health, education, social services). As a result, decision-making for the allocation of public resources is expected to be transparent (full disclosure and discussion) and will incorporate the demands and expectations of communities and citizens. Furthermore, development plans should reflect national policies and commitments to achieve the SDGs. Accountability will be enhanced during the execution of the plans and further evaluation of the results of the plans.

In addition, focusing on the field of local governance, the programme will encompass environment-related activities. Focusing on the nexus between climate action and human development, the programme will seek to enhance the capacity of local institutions to effectively implement SDG13 and SDG15. The programme will also scale up local partnerships and support climate or innovative local solutions that bring benefits across SDGs.

#### PURPOSE OF THE CONSULTANCY

The DAILL in Jordan project seeks an expert to develop a design for the Livestock Market (Souq Al- Halal) of the Madaba Governorate. The consultancy is meant to develop an environmentally friendly and sustainable design for the Livestock Market (Souq Al- Halal) in Madaba on 55 dunams<sup>1</sup> provided by the municipality while considering health and safety dimensions.

# **Objective of the Consultancy**

The main objective of this assignment is to provide a detailed design, bill of quantities (BOQ) and cost estimates of the Livestock Market (Soug Al- Halal) of Madaba. In addition to the consultant will:

- 1. Conduct a complete assessment for a multi-phased approach of the livestock market needs dimensions and requirements by evaluating the space provided within all required international health and safety provisions.
- 2. Develop a design that meets the requirements of the governorate for livestock holding, sales, and distribution.

#### **Scope of Work of the Consultancy**

The Landscape Engineer will work closely with the Greater Madaba Municipality team (GMM) and the DAILL Project manager to achieve the following tasks through a multi-phased approach:

- 1. Working closely with the Greater Madaba Municipality (GMM) team, develop a fully rounded and comprehensive data collection, site analysis, and assessment of the project.
- 2. Provide an analysis report on the allocated space for the new livestock market (Souq Al-Halal) in comparison with the old Madaba Livestock market.
- 3. Provide a design for the new Madaba Livestock Market that meets the requirements of the municipality in catering to their respective communities.

- 4. Provide the final architectural and engineering construction drawings including the fully-fledged plans (overall site plan, landscape plan, furniture plan, etc...) with the required specifications and BoQs.
- 5. Mobilise the project from the design phase to the development and initiation phase according to the plans.
- 6. Finalize and provide the official and registrations documents (stamped authorities approval and construction licenses) needed for the implementation).
- 7. All the costs and fees to be paid for official authorities (JEA, CDD, GMM...etc.) should be covered by the Consultant herein and included in the price offer for this assignment.
- 8. Assist in the UNDP procurement process and the selection of the construction contractor.
- 9. Assist DAILL and Greater Madaba Municipality in the implementation and supervision phase with the contractor.

- Experience in leading and managing architectural engineering multi-phased approach project is required. 10 Points

Only candidates obtaining a minimum of 49 points (70%) in the technical evaluation shall be considered for the financial evaluation.
