2. FINANCIAL PROPOSAL

Lump sum contracts

Payments are based upon output, i.e. upon delivery of the services specified in the TOR. For travels, all travel related cost (ticket, perdiem, accommodation, terminal transport) should be excluded from your lumpsum financial proposal since this will be paid directly by the project.
