# ATTACHMENT 1- ANSWERS TO QUESTIONS FROM PROSPECTIVE PROPOSERS

Question 1: According to the Terms of Reference, 'the SMEs will be selected through a selection process facilitated by the DAs' (p.5) and the tasks under the Deliverable 1 include 'conducting outreach activities and finalization of the application process' (p.7). Could you clarify how the SMEs to receive the training will be determined and reached out in more detail? (in terms of consultant's and DAs' responsibilities)

**Answer 1:** As clearly indicated in Annex 4 – Detailed Terms of Reference document, SMEs will be selected by the Project Team and DAs. The duty of the Contractor will be preparing training activity plan in accordance with the needs assessment conducted by the Contractor and will cover activities for outreaching the target group. The Project Team and DAs will be selecting the SMEs based on the application forms designed by the Contractor according to the needs assessment. Moreover, the Contractor is expected to conduct outreach activities (dissemination from social media, networks etc.) for an increased demand from SMEs with approval of the UNDP Project Team.

The applications for trainings and consultancy services will be received through SME Digitalization Platform (which is being developed simultaneously). The outreach activities refer to activities for increasing the number of applications, whereas selection refers to criteria-based selection among applicants.
