# Terms of Reference Motor Insurance Policy for UNDP Vehicles in Pakistan

#### **Background**

United Nations Development Programme - Pakistan intends to acquire the services of a reputed Insurance Company to provide **Comprehensive and Third Party insurance** on competitive rates for transport fleet containing 41 vehicles of different models, types and capacities within the Pakistan.

## **Objectives**

Motor Insurance policy is mandatory under the Motor Vehicle Act therefore it is decided to acquire the Motor Insurance Policy for the maximum coverage against theft, accidental damage and third party liability with greater benefits, innovative features and hassle free post and pre insurance processing.

#### **Evaluation Criteria**

The potential Insurance Company must possess the following minimum criteria for enabling them to participate in the bidding process:

- Insurance company should be registered in Pakistan, with minimum 'AA' rated Credit rating.
- Experience of at least three years providing Life Insurance service in Pakistan covering minimum five thousand Lives per year in rural areas.
- Detail Company registered office and office receiving the correspondence.
- Detail of branches/sub-offices across the country.
- Relevant documents to prove experience in the relevant field.
- Name of authorized person for dealing with UNDP and making correspondence on behalf of company.
- Detail of Clients to whom the similar facilities/services are being provided and their contact numbers for verification.
- Sales Tax & Income Tax Certificates for the last three years with NTN number.
- Affidavit that the firm/company has never been blacklisted from any Govt., Semi-Govt. & Autonomous Body.
- Having documented evidence of expeditious and unencumbered settlement of substantive claims within seven to fifteen days of lodge.
- Must have a sound financial back ground and must have minimum "AA" rating of financial strength and quick ratio of 1.
- Company should be registered with SECP (copy of registration certificate to be attached).
- Detail of category wise break up of premium amount may also be provided.

#### **Selection Criteria:**

- Lowest cost technically qualified bidder would be selected based on premium rates quoted. Quoted premium amount must be inclusive of all taxes plus operational cost if any.
- Method of premium payment e.g., quarterly, biannually, full advance etc.
- Low claim discounts.
- Detail of operational cost/administrative charges if any to be charged.
