Terms of Reference: MedTech Advisor

A. Background

UNDP is committed to contributing to overcoming the major health challenges in Somalia. The expertise built over 15 years is used to support ongoing health system strengthening reforms. The action begins with increasing equity in access to quality basic health services for the poor and most vulnerable. This includes improve access to social services and medicines for excluded groups.

This access, however, is increasingly disrupted in the Covid-19 pandemic situation. Health workers are drawn to get involved in the response to Covid-19 so that other health services are distracted. Face-to-face health services are also avoided to reduce the spread of the virus. The most impacted group on this condition is the poor and marginalized groups. They are the largest consumer of health services but is increasingly unable to access affordable and quality health services.

Concerned with this issue, UNDP assist the Somalia government in overcoming it. One of the things that has been done is to make a partnership agreement with Industry Experts in Medical Technology Space. The goal is to contribute to providing access to health services for the community through telemedicine for the underserved communities. This partnership will cover three main topics that will be worked on together, which are: (1) Evidence-based practices, (2) Advocacy to Somalia government, (3) Learning and capacity building.

Several follow-up activities for the partnership have been carried out. First is the assessment of telemedicine service providers to measure the extent to which telemedicine has been beneficial to the community. The results of the study indicate that tele-consultation services are one of the most widely accessed by the community. The next activity is to collaborate with Somalian telemedicine company under to increase the knowledge of their health workers regarding prevention, outreach, testing, and treatment cases through telemedicine.

UNDP is building a communication with the Ministry of Health. This is an initial assessment for efforts to develop better services through telemedicine. It is recognized that there has been an increasing demand for these services during the Covid-19 pandemic. The Ministry of Health also realizes that there is a need to strengthen collaboration between the government and the private sector, including telemedicine providers. This is mainly in the effort to provide access to services and to achieve the target of better healthcare for all by 2030.

UNDP together with UNFPA are going to establish telemedicine units inside the youth centers in five cities.

Telemedicine is also ideal for those with chronic illnesses. This is particularly for individuals that are well managed and only require regular check-ups, repeated prescriptions, and general monitoring. They are living with it on a successful treatment, with an undetectable viral load and stable immune function. Video or telephone consultations can answer their questions and promote retention in care.

Visual assessment in place of physical examination can be conducted. The client is asked to do some self-examination and report certain vital signs. They can also send pictures if needed. Only those who need urgent and important laboratory tests are referred to the laboratory. Meanwhile, those with acute needs can still be seen directly and contact the local General Practitioner in the Public Hospital equipped with Telemedicine units.

B. Scope of Work

UNDP Somalia is seeking the support of Medical Technology "MedTech" Advisor in the design, facilitation, implementation, and monitoring of Telemedicine innovation initiatives, including establishing the Center of Excellence (Experts Telemedicine Units) ETU & multiple Rural Underserved clinics (Remote Telemedicine Units) RTU with clear focus on creating a customized telemedicine workable model for the Somali community, under the overall guidance and supervision of the Innovation Specialist.

C. Expected Outputs / Deliverables

The overall scope of work for the Medical Technology Advisor will consist of customizing, operationalization, commissioning, supervise the management & maintenance of Telemedicine services in the proposed Hub for Somali model. The telemedicine services shall be provided through a centralized CeO "Experts Telemedicine Units" & "Remote Telemedicine units" using Telemedicine platform along with TeleMed Kit computing hardware and infrastructure consisting of cloud-based technology wired or/and wireless broad band, wide area network. The detailed scope of work which needs to be provided in order to develop the Somalian Telemedicine network which broadly be classified across the following heads as mentioned below:

- (1) Learning and capacity building
 - Creating the Training of Trainer "ToT" Champion Program

- Develop the Community awareness program
- Design the engagement program with the Medical workforce in somalia
- (2) Developing a project document for scaling up
 - Create the Rollout Strategy for Scaling up the project Nationwide
 - Create Logical Benchmark & Key Performance Indicators

D. Institutional Arrangement

The MedTech Advisor will directly be supervised by innovation Specialst, UNDP Somalia. Specific timeline for delivery of services will be agreed with the supervisor at the beginning of each month. Payments will be made (once a month upon submitted satisfactory timesheet and progress report against deliverables and upon its acceptance by the Supervisor Travel costs related to the missions in somalia, will be paid separately to the Consultant as per UNDP rules and regulations. Duration 2 Months; Up to a maximum of 40 working days spread over a period of 2 Months including up to 1 missions to Somalia (up to 20 working days).
