1. Office/Unit/Project Description

The United Nations Environment Programme (UNEP) is the leading global environmental authority that sets the global environmental agenda, promotes the coherent implementation of the environmental dimension of sustainable development within the United Nations system and serves as an authoritative advocate for the global environment. The West Asia Office of UNEP delivers advisory services and capacity-building support to countries to achieve environmental and sustainable development objectives. This consultancy is established at the West Asia Office within the framework of the Strategic Cooperation Agreement between UNEP and the Ministry of Environment, Water and Agriculture (MEWA) of the Kingdom of Saudi Arabia. The Consultant will report to the Programme Manager at UNEP West Asia Office.

This Consultant will work closely with UNEP, the Ministry of Environment, Water and Agriculture and its executive centers in Saudi Arabia, all other governmental entities involved.

2. Scope of Work:

Under the direct supervision of the Programme Manager in UNEP West Asia Office and in coordination with the respective department in the Ministry of Environment, Water and Agriculture in Saudi Arabia, the Consultant will carry out, inter alia, the following duties and responsibilities:

- Participates in the development, implementation and evaluation of assigned activities in relation to the implementation of multilateral environmental agreements (MEAs) ratified and complied by KSA, including those related to biodiversity, chemicals and hazardous waste, oceans, desertification and climate change.
- Liaises with relevant MEAs, identifies, and tracks MEA decisions requesting for KSA follow-up actions and reporting to the relevant MEAs governing and subsidiary bodies.
- Performs consulting assignments, in collaboration with the secretariats of related MEAs, as well as relevant partners in planning facilitating workshops, through interactive sessions and assisting in developing the action plan for KSA to implement their obligations under various related MEAs.
- Researches, analyzes and presents information gathered from diverse sources on emerging issues on protection, conservation and sustainable use of biodiversity, climate change, chemicals and waste, desertification, among others.
- Assists in policy development, including the review and analysis of environmental governance issues and trends, preparation of impact evaluation or equivalent studies, etc.

3. Expected Outputs and Deliverables

The Consultant will be expected to deliver the following outputs:

- Trainings for MEWA and executive centers staff on the implementation of various MEAs related to biodiversity, chemicals and hazardous waste, oceans, desertification and climate change among others.
- A comprehensive report of the status of implementation of various international agreements in KSA.

4. Institutional Arrangement

The Consultant will be supervised by the Programme Manager in UNEP West Asia Office in close collaboration with the relevant department in the Ministry of Environment, Water and Agriculture of Saudi Arabia.

5. The duration of the assignment:

The contract duration will be for an initial period of six months with a possibility of extension subject to availability of funding and performance.

6. Location:

This assignment will be based in Riyadh, Saudi Arabia.

7. Travel:

- UNDP/UNEP will cover the cost of travel of the individual to the duty station, as well as their return to their home upon completion of their services. Travel costs are covered only in the event that the function will be undertaken physically in the duty station and exclude working from home arrangements.
- Include any official travel expected to be associated with performing the functions.

Individual consultants will be evaluated based on the following methodologies:

Step I: Screening and desk review:

Individual consultants will be evaluated based on the following methodology. **Technical Criteria (CV review and Desk Review/Interview optional) – maximum 70 points.** Only candidates who obtained **at least 70% of points from the CV desk review (who will score at least 49 points)** will be considered for the next stage of evaluation, i.e. financial evaluation.

Applications will be first screened and only candidates meeting the following minimum criteria will progress to the pool for shortlisting:

- Educational qualifications: Advanced degree (Master's) PhD will be desirable in environmental science, law, political science, international relations or equivalent or any other relevant field
- Minimum of 10 years of relevant work experience in Multilateral Environmental Agreements.

- Knowledge of environmental issues in Saudi Arabia is an asset
- Fluency in spoken and written English. Arabic preferable/desirable as indicated in the CV
