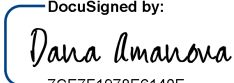

**Conferencing facilities for UNDP Maldives office retreat**

**A - BACKGROUND**

UNDP is the UN's global development network, an organization advocating for change and connecting countries to knowledge, experience, and resources to help people build a better life. UNDP is on the ground in about 170 countries and territories, working with national counterparts on solutions to global and national development challenges. In the programme countries, UNDP supports stabilization, state-building, governance, and development priorities in partnership with the host governments, the United Nations system, the development partners and other partners to help the country to achieve sustainable development by eradicating poverty in all its forms and dimensions, accelerating structural transformations for sustainable development and building resilience to crises and shock.

UNDP has been a trusted development partner of the Maldives for more than 40 years, helping to achieve the eradication of poverty, reduction of inequalities and exclusion in areas such governance, environment protection, climate change mitigation and adaptation. In each of its thematic areas of work, UNDP at the request of its national partners provides relevant policy advisory support, technical assistance, advocacy, and knowledge to help Maldives achieve its global commitment on Sustainable Development Goals (SDG). With Maldives's transition to Middle Income Country Status, Official Development Assistance from traditional donor sources has been on the continuous decline. UNDP is therefore working with its national partners to identify and tap into alternative and innovative financing mechanisms for development. This process involves broadening outreach and forging wide-ranging partnerships with stakeholders - including other UN agencies, the government, the private sector, philanthropic Foundations, multi-lateral and bi-lateral donors and International Finance Institutions to advance the country's development strategies and objectives.

The United Nations Development Programme (UNDP) in Maldives will have a three-day staff retreat in March 2022. The primary aims of the staff retreat include, strengthening team spirit and communication within the country office; review of the country office priorities and work plan for 2022 as well as the results and achievements of the office to date; and further promote a cohesive, process driven, innovative and result-oriented team to implement the work of UNDP Maldives.

The Staff Retreat comes at a critical turning point in the life of UNDP Maldives when it seeks to re-position itself to address the developmental results in the new Country Program Document. A service provider is required to provide conferencing facilities for the retreat including accommodation and meals.

**B - DUTIES AND RESPONSIBILITIES****Scope of Work**

The retreat will bring together UNDP personnel and Retreat Facilitators for a three-day retreat. The purpose of these Terms of Reference is to request provision of accommodation on full board for 45 participants, a conference package including meeting facilities and refreshments made available throughout the duration of the workshop, by a contractor/vendor (hotel) that can fulfil the required deliverables and criteria as below.

## Expected Outputs and Deliverables

The contract price will be fixed output-based price regardless of extension of the herein specified duration.

##### **Cumulative analysis**

The award of the contract shall be made to the individual consulting firm whose offer has been evaluated and determined as a) responsive/compliant/acceptable; and b) having received the highest score out of set of weighted technical criteria (70%). and financial criteria (30%). Financial score shall be computed as a ratio of the proposal being evaluated and the lowest priced proposal received by UNDP for the assignment.

Technical Criteria for Evaluation (Maximum 70 points)

•Criteria 1: Provision of all specified conferencing resources, accommodation, and other facilities for the duration of the activity.

Only candidates obtaining a minimum of 49 points (70% of the total technical points) during the desk review/interview are acceptable would be considered for the Financial Evaluation.
