## **Scope of work of Rehabilitation of al Bu Hashem and al Bu Nassir C.U 50m<sup>3</sup>/hr. in Yathrib -Salahdien Governorate**

### **1. Project background:**

The project is located in Yathrib District, Salah al-Din Governorate, and is considered one of the important projects for this region, as it provides potable water to many areas in Yathrib District, including the villages of Al-Bu Hashem and Al-Bu Nassir, and other areas and serves more than 4000 thousand beneficiaries.

The project had been established in 2011, with a total capacity of 50 m<sup>3</sup>/h.

After the events of ISIS in 2014, all the mechanical and electrical equipment of the project were stolen, and the buildings have been damaged.

Currently, the project is in urgent need to rehabilitate to deliver water to the areas after the return of its residents from displacement and they do not have any source of water except for irrigation canals.

### **2. Location:**
