SCOPE OF WORKS

Project title: Peace & Community Cohesion (PaCC)

Activity: Additional works for construction of Fence & Shade, Wullu.

Expected duration: 30 Calendar days

This SOW should be read in conjunction with the attached drawings. All the works shall be according to proper codes of practice and to the satisfaction and approval of UNDP representative on site.

LOCATION:

The proposed construction works are at the Lulu works Women cottage industry in Wullu County. The works for the under the construction include the following:

MOBILIZATION/DEMOBILISATION

The contractor must mobilize required equipment, personnel, and materials to the site and demobilize out of site after completion of the works in accordance with UNDP Engineer's approval.

CLEANING OF THE CONSTRUCTION SITE

The contractor shall do site clearance, removal of small trees, vegetation and debris then dispose off the site including preparation of site for commencement of works. The UNDP Engineer shall show the location for disposal. When all works are completed, the Contractor must remove any construction debris, remove, or flatten as shall be instructed by the Engineer and make the whole area of the site clean and ready for use.

CONSTRUCTION OF FENCE

Chain link mesh on Angle steel section support posts with tension wire stiffeners, with concrete lining at the base, steel grilled gate pedestrian gate/door supported with SHS steel columns. The top is finished with barbed wire strands in three lines and non-electric razor wire 450mm diameter. The length of fence is approximately 60m surrounding the PV modules.

CONSTRUCTION OF GENERATOR SHADE

Masonry brick substructure walls and SHS steel column frames supporting, steel sheet roofing on steel roof structure, rendering of the plinth walls, painting all steel and masonry members, in-situ concrete floor finished monolithically.

SECURITY LIGHTING

This includes supply and installation of 4no. standalone solar powered security light posts as directed by the UNDP Engineer.

PROTECTION OF UNDERLAYING SERVICES

The contractor shall during excavation allow for protection of all underground services including water and power lines and ensure reinstatement after completion of works.
