Q and A session

Q1. How do you think this project should be implemented, fully online, or do you consider on-site visits as well?

Answer. Unlike previous projects that were implemented online, now the focus is on face-to-face communication, given that a large part of the Covid regulations have already been removed.

Q2. Do you have information or data on how many young people live in these regions? They usually travel to larger cities after school to continue their studies in higher education. That is why it is crucial to have information about the young people living in the area, the actual number of the segment for whom this grant program is intended.

Answer. We do not have the latest data, although we for sure know that young people live, work and study in these regions. The context of their needs, age groups, interests and what we can do for them depends entirely on the applicant organization.

Q3. We established a youth center in Borjomi. The organization has not yet received legal registration, and we are wondering if we will be able to participate in the competition.

Answer. After obtaining registration, you will be able to. Please also acknowledge the competition rules regarding the legal status of the applicant organization and the required experience.

Q4. How many regions can one applicant organization cover?

Answer. At least one

Q5. Does the organization established in Tbilisi have the right to participate in the competition?

Answer. We have no restrictions in this regard.

Q6. Can the development of young people skills be considered in any direction?

Answer. We have no restrictions in this regard.

Q7. When will we know the results of the competition?

Answer. Maximum 20 days after the end of the competition.

Q8. At least 2 projects will be funded according to the application. What will be the priority, projects that will cover more municipalities?

Answer. Priority will be given to the best bids that will meet the requirements of our competition and not the size of the geographical area covered.
