A. Background and Context

Peace and Development Officers (PDAs) are cross-pillar assets provided for Resident Coordinators to ensure that sustaining peace is mainstreamed throughout the United Nations Country Teams' work. PDAs bring unique political, peacebuilding and development skills to RCs and UNCTs. Their role in facilitating a whole-of-system approach to conflict prevention supports the objectives of the Secretary-General's reforms.

Peace and Development Officer are deployed through a global partnership between the UN Department of Political and Peacebuilding Affairs (DPPA) and the United Nations Development Programme (UNDP), under the Joint UNDP-DPPA Programme on Building National Capacities for Conflict Prevention. The Peace and Development Team in Kenya comprises the Peace and Development Advisor, the National Peace and Development Officer, and several consultants. The Peace and Development Team is placed in the Resident Coordinator's office. The Peace and Development Team's work focuses on the prevention of electoral violence, supporting national and local capacity for peace and development, analyzing political developments and conflict dynamics, and mainstreaming conflict sensitivity in development programs. The Consultant, stationed in the Office of the UN Resident Coordinator, will work closely with the UN Peace and Development Advisor to provide the UNCT with regular monitoring, analysis and regular reports on political developments and topical issues, and violence risk in social media and other media platforms (with special focus on gendered hate speech), countering misinformation and disinformation, and dissemination of positive and counter-messaging to prevent violence before, during and after Kenya's general elections in August 2022

Kenya is entering its elections year with increasingly polarized politics and debates, challenging socio-economic inequalities exacerbated by COVID-19, climate-related crises, as well as a shifting regional landscape which threatens security and stability in parts of the country. These key drivers, amongst others, will contribute directly and indirectly to shaping peace and conflict dynamics as Kenya heads towards general elections in 2022. Within this context, and in support of the Resident Coordinator's overall mandate for conflict prevention, the Peace and Development consultant will contribute to efforts to equip the UN and national stakeholders with regular updates and credible, conflict-sensitive tools to inform and support early warning engagement and timely interventions to address and mitigate risks before and after the August 2022 general elections.

B. Objectives and activities of the Assignment

By providing regular analysis of the political environment, institutional preparedness for elections, election-related violence reduction, and other topical issues, the Consultant will:

- a) Strengthen a broad and holistic understanding of peace and conflict dynamics, risks, opportunities, and priorities for a response during the electoral period and beyond
- b) Enhance stakeholder engagement and debate on electoral politics, peace, and cohesion
- c) Enhance UNCT's understanding of violence risk and opportunities for prevention and mitigation

C. Scope of work and deliverables

- a) Provide regular updates and background information on political events and their implications for peace and cohesion
- b) Support analysis of the state of institutional preparedness of the IEBC and other electoral institutions for the 2022 elections and the transition period
- c) Support evidence-based analysis of peace and conflict dynamics at the national and subnational level to guide UN response to identified risks and opportunities
- d) Support risk assessment in select hot spot counties and urban informal settlements
- e) Provide gender analysis of the political events, including campaigns and electoral outcomes
- f) Support the work of the Prevention Platform, including regular updates
- g) Support the identification of data sources and linkages with experts and institutions upon request
- h) Provide analytical or other support to the Early Warning project upon request
- i) Provide substantive support to engage with partners and in resource mobilization initiatives, including through preparation of funding proposals, briefing notes, timely corporate and donor reporting, advocacy, and information-sharing requirements.
- j) In collaboration with UWIANO Technical teams, support activities, advocacy campaigns, events, development of messages and dissemination including on social media.
- k) Perform other relevant duties as required.

The main deliverables under this assignment are:

- Bi-weekly political updates and ad hoc briefs on key political events
- Mapping of peace actors and their views about the elections
- Background reports on topical issues e.g., court decisions
- Monthly multi-dimensional risk analysis report for the Prevention Platform
- Databases on main sources of data, including institutions and contact details
- Conflict assessment reports from urban informal settlements and hot spot counties
- Monthly update on institutional preparedness of the IEBC, National Police Service and other electoral institutions for the elections and transition period
- Reports on mediation activities, best practices, and lessons
- Summary notes and action points from meetings with strategic stakeholder meetings

D. Timelines and Duration of Service:

The work will commence as soon as the contract is ready and is expected to be concluded within 6 months of the start of the contract.

E. Logistics and Administrative Support

Travel: Limited_travel is expected between Nairobi and at least two hot spot counties (Uasin Gishu and Marsabit) – for three days each.
