# **Description of Requirements**

# Context of the Requirement

Africa borderlands are notable for enormous innovation and creativity, and they contain human and natural resources to support inclusive socio-economic growth. These potentials are often disguised by stories of crises, insecurity and poverty. These stories amplify and spotlight the vulnerabilities rather than the resilience of the borderlands. The Africa Borderlands Centre (ABC) was established to influence a new pathway to implement development assistance in the borderlands, based on the unique experiences, strengths and bottom-up approaches that work for these marginal spaces. The ABC will articulate a mix of traditional/ local knowledge, social resilience building mechanisms which provides solutions to a wide array of challenges, and time-tested traditions, practices and approaches that are at risks of becoming extinct.

In 2021, the ABC launched an 'innovation challenge' focused on Improving Livelihoods for Informal Cross Border Traders and borderland Trading Communities. The goal of the Innovation Challenge was to curate, experiment and upscale local borderland innovations that have become the lynchpin of entrepreneurship culture, which has sustained Informal Cross-Border Trade (ICBT). The social innovation ideas are focused on digitization of funding and logistics chain; upscaling e-payment capabilities of all thrift and credit societies; and improving products value chain through digitization. In implementing four innovative ideas across ten African countries, ABC Staff immersed themselves in the borderlands space for sensing and collective intelligence exercises. A significant lesson learned in this process was the awareness of a wide array of innovative practices that have contributed to the resilience and survival of borderland communities. The immersion exercises also illuminated the opportunities to uncover the strengths and catalyze the borderlands' development to attain the Agenda 2030, as encapsulated in the Sustainable Development Goals (SDGs). Therefore, the pathways identified for future investments in the borderlands are agriculture and pastoralism, informal cross border trade, infrastructure, and social cohesion.

Based on lessons learned in the interaction with borderland communities, the ABC in 2022 developed a portfolio approach for area-based programming in the borderlands, focused on the four pillars as follows:

Pillar I: Strengthen agriculture and livestock production productivity and enhance associated value and supply chains.

Pillar II: Provide access to finance, support entrepreneurship and strengthen the capacity of micro and small enterprises.

Pillar III: Invest in climate-resilient small infrastructure to enhance production and trade.

Pillar IV: Strengthen vertical and horizontal social cohesion.

These pillars provide entry points for the ABC to partner with the borderland stakeholders to enhance their resilience. An essential element in the partnerships

is the elevation of the borderlands innovators' voices to tell their stories on how solutions have been provided to address challenges confronting them. In the light of the foregoing, the ABC seeks the services of qualified Behavioral Communications or Research Firms to map and develop a comprehensive brochure (compendium) of the innovative solutions to socio-economic challenges in the borderlands. Due to the complex nature of the assignment, the ABC seeks Firms with solid expertise and experience in crowd-sourcing across remote and far-flung borderlands in Africa. The Firm will be specifically required to provide short stories, pictures, photographs and short videos of the specific innovations mapped in the borderlands. **Implementing UNDP** Partner of UNDP Brief Description of **Overall Objective:** the Required The overall objective of the assignment is to deliver a brochure (compendium) of Services<sup>1</sup> curated home-grown innovative solutions to socio-economic challenges across the 106 border pairs and trios in Africa. **Specific Objectives:** The specific objectives of this Consultancy are to: 1) Develop comprehensive standards and criteria for articulating innovative solutions across the four pillars of ABC's work from Africa borderlands. 2) Analyse locally developed innovative solutions across the 106 border pairs in Africa borderlands, including their relevance for resilience-building and acceleration of development impact. 3) Contribute to the review and validation of the draft report. 4) Produce a publishable brochure (compendium) of locally developed innovative solutions to socio-economic challenges in Africa borderlands. This should include human-centred stories and pictures for each case study. **Project Overview:** 1. Support methodology design: Undertake the design of the method, process and substance of curating stories, videos, photos and pictures for innovative solutions in the borderlands. 2. Contextual Analysis: Provide the socio-economic, security, political and environmental contexts (with data, facts, figures and illustrations) in which the innovation in the borderlands is taking place. 3. Analysis of Innovative Story: Undertake the compilation, collation and analysis of 50 stories of innovative solutions from 106 border pairs in Africa, based on the four thematic areas outlined.

- **4. Photography:** Produce 80 high-quality photographs (2 per story) that illustrate the 50 stories of innovation in Africa borderlands, based in the four thematic areas.
- **5. Design and Publishing:** Make substantive contributions to validating, designing, and publishing the solutions mapping (online and offline versions).

### **Thematic Focus of Innovation Mapping:**

- I. Local Solutions to Agriculture and Livestock Production and Productivity that Contributes to Value and Supply Chains:
- a. To analyse solutions that improve the quality of yields despite climate change impact.
- b. To analyze storage methods, preservation and management of yields in a profitable manner.
- c. To curate innovative approaches that have connected borderland farmers and pastoralists to value and supply chains.
- d. To account for how women and youths have overcome social challenges to improve their profitability in the agriculture and livestock sectors.
- II. Local Innovative Solutions that Improve Access to Finance, Support to Entrepreneurship and that Strengthens the Capacity of Micro and Small Enterprises:
- a. To analyze solutions that have led to new funding pipelines for the most vulnerable borderland businesses.
- b. To analyze an innovative support system that has enhanced business survival despite the socio-economic impact of COVID-19.
- c. To analyze how borderland small businesses have partnered with the private sector to improve access to finance and competitiveness.

- a. To identify improvised but innovative infrastructure built by borderland stakeholders to fill gaps created by lack of government infrastructure.

Africa borderlands are notable for enormous innovation and creativity, and they contain human and natural resources to support inclusive socio-economic growth. These potentials are often disguised by stories of crises, insecurity and poverty. These stories amplify and spotlight the vulnerabilities rather than the resilience of the borderlands. The Africa Borderlands Centre (ABC) was established to influence a new pathway to implement development assistance in the borderlands, based on the unique experiences, strengths and bottom-up approaches that work for these marginal spaces. The ABC will articulate a mix of traditional/ local knowledge, social resilience building mechanisms which provides solutions to a wide array of challenges, and time-tested traditions, practices and approaches that are at risks of becoming extinct.

In 2021, the ABC launched an 'innovation challenge' focused on Improving Livelihoods for Informal Cross Border Traders and borderland Trading Communities. The goal of the Innovation Challenge was to curate, experiment and upscale local borderland innovations that have become the lynchpin of entrepreneurship culture, which has sustained Informal Cross-Border Trade (ICBT).
