Scope of works

1. Title

Construction and installation of the classroom and an amphitheater in B2 district of Yerevan.

2. Project Title

Yerevan 2.0: towards more inclusive and greener recovery

3. Project Description

The burden of the coronavirus (COVID-19) epidemic in the Republic of Armenia has been among the highest in the world when comparing the incidence rates, affecting nearly every aspect of social and economic life in the country. According to the findings of the recently conducted Socio-economic Impact Assessment of the COVID-19 Outbreak in Armenian Communities (SEIA), the capital Yerevan and consolidated communities with an urban center were the hardest hit by the crisis when looking at the combination of multiple socio-economic dimensions.

With an emerging need to rethink cities' development across social, cultural, economic, and environmental dimensions, the project comes to support Yerevan (capital) city to build forward better by adopting a more comprehensive approach for systemic, inclusive, and greener recovery from the COVID-19 crisis, focusing on data.

UNDP Municipal sectoral Services team, within Yerevan 2.0 project, is optimizing and redesigning the services related to the public spaces by creating the multifunctional public space, which will serve as an outdoor classroom for four educational institutions.

4. Scope of Work

Within the Municipal sectoral Services Component, the project team will build and install natural science classroom and an amphitheater.

Task 1. Supply of required quality of an amphitheater. Supplier should build the amphitheater based on the required design and parameters. Detailed specifications for the amphitheater are provided in Bill of Quantity and Design files.

Task 2. Supply of required quantity of classroom (container). Supplier should build the classroom based on the required design and parameters. Detailed specifications for the natural science classroom are provided in Bill of Quantity file.

Task 3. Delivery and installation of classroom and amphitheater. Supplier should deliver and install the classroom and the amphitheater in "Love and Faith" park which is in B2 district of Malatsia - Sebastia administrative district and located between Shahumyan 4th, 6th and 7th streets. The exact address will be provided closer to the delivery date.

Task 4. Reporting. The Supplier should provide the detailed report on the assignment including the certificate for equipment safety, as well as photos of the playground.

5. Duration of the Work

50 calendar days after signing the contract.

6. Qualification of the organization

Proposal can be submitted by a registered legal entity, with experience in the above-mentioned works:

- Have at least 3 years of professional experience in the below task
- Deep understanding of tiny houses and amphitheater technical specifications.
