During the presentation the following questions and inquiries were raised by the bidders:

	#	Questions Raised During the Meeting	#	Answers
		How much is the minimal cash flow or the financial capacity to apply for two Lots?	A1	As stated in the RFQ document, companies applying for more than one LOT should demonstrate additional US\$ 15,000 turnover for each additional LOT as below: For one LOT: US\$ 25,000 For two LOTs: US\$ 40,000 For three LOTs: US\$ 55,000 For four LOTs: US\$ 70,000 For five Lots: US\$ 85,000 For six Lots: US\$ 100,000 For seven Lots: US\$ 115,000
	Q2	Is it allowed to submit the documents in the hardcopy? In Timor-Leste, the internet connection is not good sometimes. Thus, the hardcopy submission will be easier.	A2	No, the hardcopy submission is not accepted.  The submission should only be via email to (bids.tp@undp.org) as mentioned in RFQ document. And DO NOT CC other EMAIL ADDRESSES.  The hardcopy documents can be scanned and converted into PDF.  If the file size is bigger than 10MB, the bidder should send separate emails, each less than 10MB.
-		Should the technical & financial documents be sent all together?		The bidders should submit all required documents together in one email or multiple emails before the tender closing date.
	Q4	Is Bid security needed?	A4	No, the Bid Security is not required for this RFQ.
		Do the documents need to be secured with a password?	A5	No, password to the documents are not required.

Is it required to submit the contract showing the past experience? If it is not necessary, the experience can be lied or manipulated.

UNDP requires bidders to submit list of contracts completed during past 5 years which reference details, contract value, description of work and duration.

UNDP will verify the information during evaluation process when required and will conduct reference check with previous clients.

UNDP may also request copy of the contracts (if required) from the recommended bidder as post qualification process.

UNDP informed attended bidders that they can send their requests for clarifications till seven (7) calendar days before the submission deadline date.

All the received bidders' questions and UNDP's answers will be published on UNDP website to be available for all interested bidders.
