Background and Justification

Child abuse and neglect remain a worrisome issue in Botswana. The Violence Against Children Survey (VACS), 2016 states that among children aged 13-17 years who had ever had sexual intercourse, one in four females (25.1 per cent) and one in twenty males (4.6 per cent) experienced unwanted sex at the time of their sexual debut. Children in Botswana also experience high levels of physical abuse and the VACS shows that 43 per cent of boys and 28 per cent of girls experience physical violence and 14 per cent of both sexes experience emotional violence.

In Botswana, police records indicate an increase in sexual violence during the 2020 COVID-19 lockdown, illustrated through a 20 per cent increase in defilement cases. This situation resulted from children spending more time at home than school with potential abusers, who are often family members or known to the family. Referral mechanisms for cases of child abuse and sexual assault are weak, and there is a limited number of specialized juvenile justice personnel in both the police and justice system.

The low reporting of cases of abuse with only one in nine girls reporting cases of rape to the police and only one in seven seeking medical attention remains a concern. COVID-19 restrictions at the time significantly reduced access to services for children facing abuse. There is highly likelihood that the number of unreported cases is even higher.

In efforts to improve access to justice by children one child-friendly police station was established in 2020 in Gaborone through advocacy from UNICEF and another in Francistown in 2021. Similar services are lacking in rural areas in Botswana. UNICEF through the Japanese funding aims to increase access to child friendly police station by children in hard-to-reach areas and the targeted locations are Shakawe, Ghanzi and Letlhakane.



Objectives and Work Assignment

Goal and Objective: To supply 3 porta cabins in three locations in Botswana to be used as the Child Friendly Police Centers.

Under the overall guidance of the Botswana Police Service (BPS) and in collaboration with UNICEF's Child Protection Section, the assignment will be responsible for the following key activities and tasks:

Activities and Tasks:

- I. Liaise and work collaboratively with Botswana Police Service (BPS) and UNICEF to provide the following services:
 - a. Construct 3 porter cabins according to the provided specifications
 - b. Deliver the porter cabins to the 3 identified sights being Shakawe, Ghanzi and Letlhakane

Work relationships: The assignment will be supervised by the Botswana Police Service and UNICEF team consisting of the Deputy Director Gender and Child Protection (BPS) and Child Protection Specialist (UNICEF). BPS as an implementing partner will oversee and carry out sight visits to the selected supplier and approve any work done before it is delivered. Both BPS and UNICEF will visit the 3 areas after delivery of the porter cabins to ensure they meet the requirements by the targeted police stations.

Outputs/Deliverables:

- a) Construct porter cabins **Timeline: 1st July 2022**
- b) Deliver first porter cabin in Shakawe
 Timeline: 14th July 2022
- c) Deliver the second porter cabin in Ghanzi
 Timeline: 22nd July 2022
- d) Deliver third porter Cabin in Letlhakane
 Timeline: 1st August 2022


