Q1	There's no Fee for Materials Testing, while all testing is required/mention in the BOQ.		The material testing should be conducted at the construction site. Once a company start the construction, the materials should be certified/approved by UNDP's Engineer/Technical Team
	There's no LADDER item for water tower (Drawing of BOQ), which we think is necessary.		The Ladder is not necessary to be included.
Q2 Q3	we are suggesting if you could separate Overhead and Profit? Government of RDTL already separated those two items since around 2014		Either way, separating or combining those two items is okay and acceptable.
Q4	Please explain about Confirmation on warranty.	A4	Warranty confirmation letter: Warranty is for a minimum period of 1 year from the date of handover of the work. Acceptance of Defect Liability Period (12 months after completion of work) and retention of 10% from total contract value.
Q5	Majority of local companies do not have any audit report. Can we prepare an internal audit report to attach with financial statement?	A5	If your company is not required to submit audited report by law in Timor-Leste, then please submit unaudited Financial statement and Bank statement.
Q6	Can UNDP assist the bidders by providing the internet? The internet connection is poor especially in municipalities to participate in etendering.
