#### Appendix I Terms of Reference for Pre-qualification of the bidders

#### Background

The United Nations Development Programme (UNDP) Sierra Leone Country Office intends to shortlist interested and qualified companies. As such, UNDP is soliciting expressions of interest and information for the prequalification of suppliers for the provision of various goods and services.

Applications must supply all information and documents requested and providing only part of the requirement will be rejected. UNDP at its discretion may approach the applicant for further clarification or documents. However, failure to supply sufficient information in the application may lead to disqualification. The Applicant is expected to examine all corresponding instructions, forms, terms contained in these Pre-qualification application document and failure to comply there is a risk of disqualification.

Upon completion of pre-qualification exercise, UNDP may launch tender process to establish Long Term Agreements for respective identified categories of goods and services using the list of vendors qualified under this EOI exercise. UNDP may also use the list qualified vendors for any local shopping process.

#### Language of Submission

Your application and supporting documents should be in English Language only. If the original document(s) submitted are not in English, English translation of the same should be attached with the said document(s).
