Mr. Ehsanul Karim Chowdhury from the UNDP Country Office's Procurement Unit welcomed all the participants. Mr. Clifford Rodrigues then highlighted the process and compliances for bid submission. He also explained the following procedures: (a) how to register in UNDP e-Tendering system and (b) how to submit a proposal on e-Tendering; he also provided an outline of the Technical and Financial proposal submission process. It was also emphasized during the meeting that if any bidder wishes to enter into a Joint Venture or Consortium with other bidders, they are welcome to do so, and in order to do that, the bidders need to complete the Joint Venture form, including submission of the Letter of Intent and a formal agreement with the other entities as required by the RFP document. Then Ahmad Rashid Watanpahl explained the technical requirements of the TOR.

The participants were then allowed to ask questions for further clarification about the assignment and bid submission process. Following were the questions asked in the meeting or received through the PNG Procurement email and the responses provided by UNDP.
