If you are submitting your Proposal by email, kindly ensure that they are signed and in the .pdf format, and free from any virus or corrupted files.

Services proposed shall be reviewed and evaluated based on completeness and compliance of the Proposal and responsiveness with the requirements of the RFP and all other annexes providing details of UNDP requirements.

TERMS OF REFERENCE

Technical Consultancy Services to Develop Strong Wind Agricultural Insurance Product as Part of the Agricultural Insurance Programme in Armenia

1. Background

With financing from the Green Climate Fund, the "National Adaptation Plan (NAP) to advance medium and long-term adaptation planning in Armenia" project (the Project) supports the Government of Armenia to develop a national plan for climate change adaptation (CCA) through an iterative process focused on strengthening foundational capacities to ensure that they are institutionalized for longterm sustainability. The Project aims to address existing barriers, support the prioritization of climate change adaptation measures and investments in priority sectors, including in agriculture sector.

The agricultural sector is one of the most important economic sectors in Armenia. However, despite its significant role for the country, agricultural productivity stays below its potential. One of the reasons was the lack of effective risk management systems, including the absence of agricultural insurance, which could shield farmers from local weather perils (e.g. hailstorms, drought, floods, frost, excessive precipitation, windstorms, etc). This in turn is one of the key factors explaining the lack of investment in agriculture sector. A 2014 World Bank study¹ concluded that Armenia's agriculture would become increasingly vulnerable to the effects of climate change, expecting to register; higher temperatures, reduced river runoff, greater variability and overall reduction of precipitation, as well as an increased frequency and severity of extreme weather events.

In order to better manage climate risks in the agricultural sector of the Republic of Armenia, the Government of the Republic of Armenia has initiated the introduction of an agricultural insurance system with factual implementation work started in 2016. In 2019 the Central Bank of Armenia has established the "Agriculture Insurers' National Agency" NGO (AINA) for the organization of agricultural insurance process and coordination of the agricultural insurance activities in Armenia. AINA is a PPP body and financed exclusively on private basis – from the member insurance companies.

Agricultural insurance started as a pilot programme and the agricultural insurance products have been introduced in stages. In a first stage (beginning in 2019), 18 insurance products were implemented covering 3 perils (frost, hail, and fire) and 14 crops. In a second stage (beginning in 2021), a 4th peril (drought) was added to the programme and the total of crops increased to 15.

The pre-implementation feasibility study and the pilot implementation phase suggested that strong wind is a further significant peril and that the development of relevant insurance products to cover this risk is important for the further development of the agricultural sector in Armenia. For the Government of Armenia, it is a priority to have the strong wind risk included in the next phase of Agricultural Insurance Programme implementation.

2. UNDP/GCF Project Objective

With the development of a NAP process, Armenia will lay the groundwork for the systemic and iterative identification of medium- and long-term risks, establish adaptation priorities and build out specific activities that ensure no one is left behind in the country's work to reach its goals outlined through the Paris Agreement and 2030 Agenda for Sustainable Development. As part of the localization of the Sustainable Development Goals (SDGs), the NAP process will contribute to the formulation of corresponding national climate-responsive indicators and targets.

3. Objective of the assignment

Strong wind is one of the major perils that impacts crops in the Republic of Armenia. UNDP, AINA and the Ministry of the Economy of Armenia are therefore interested in developing an insurance solution for this risk.

The objective of the task is to design a strong wind insurance product, accompanied by appropriate loss adjustment guidelines, to ensure relevant crops that are already insured by the Agricultural Insurance Implementation Programme (through existing products such as hail, frost, fire, and drought insurance) and/or for new crops that are not currently covered by this programme. In this scope it will be necessary to assess the local market for agricultural insurance from the perspective of market needs, with a view to developing an appropriate strategy that provides protection for farmers in the case of strong wind, enhances investment in the agricultural sector by enhancing predictability of yields and revenues, and reduces the need for government intervention in the case of extreme events related to strong wind. The task is to be built on the successes of the Agricultural Insurance Programme of Armenia so far and based on collaboration with AINA, the Central Bank of Armenia and the Ministry of Economy of Armenia.

4. Scope of Work and Specific Tasks of the Consultancy

Under the overall guidance of the UNDP Climate Change Program Coordinator and the UNDP-GCF Project Manager, and direct oversight by the NAP Project Management Unit, the Consulting Company will be responsible for the following activities:

Task 1. <u>Development of a Work Plan:</u>

• The consultant should develop a Work Plan (including a timeline) outlining the tasks necessary to achieve the objectives set out in these Terms of Reference. The Work Plan should include the phases of the assignment, timing, key deliverables, and milestones.

Deliverable 1: Work Plan submitted and approved.

Task 2. Development of a Strong Wind Insurance Product:

- Collect available data and research on the various aspects related to the insurance object (biological characteristics and technology of growing crops, agrometeorological conditions, yield data and statistics, production and natural risks and their impact). Conduct farmer interviews to obtain qualitative evidence on the incidence of strong wind for different crops and to better understand market demand for strong wind insurance.
- Conduct analysis of quantitative data and qualitative information collected during desk and field research allow for the importance strong wind risk to be better understood and quantified – and provide the basis for the design of appropriate insurance solutions. In consultation with key stakeholders select the most important crops to benefit from strong wind insurance. The product prototype emerging from the design process is to be reviewed by the various workflow participants, before being presented to the key stakeholders. Actuarial analysis is to be used for the development of a pricing strategy and tariff rates for the product. Specific consideration is to be given to the feasibility and desirability of

standalone strong wind insurance relative to a bundled product. The Consulting Company will organize the presentation of the result of the actuarial analysis to the stakeholders and consolidate feedback to be provided to the Programme Reinsurer.

 Present the pricing and product design documentation for discussion with the Programme Reinsurer. The product development process is to be completed with finalization of the insurance product term sheet and its presentation to AINA and the insurance companies participating in the Agricultural Insurance Programme.

Deliverable 2: Strong Wind Insurance Product as Part of the Agricultural Insurance Programme in Armenia developed.

Task 3. Development of Loss Adjustment Guidelines:

- Develop loss adjustment methodology and guidelines based on the approved insurance product concept, as well as on the research data collected on biological and technical aspects of the cultivation of a relevant crop with focus on the phases of crop development and the impact of the specified risk in a specific period, as well as the level of possible damage after exposure to the risk.
- The concept of the methodology is to reflect the required procedure for 'fixing' and determining the level of damage in the orchard, field, or plot. The various algorithms guiding loss adjusters are to be described in detail in the loss adjustment guidelines, including calculation models and examples. Study and record the impact of the uninsured risk.
- Supplement the guidelines with photographic material, service forms and (if necessary) yield referent data tables.

Deliverable 3: Loss Adjustment Guidelines for Strong Wind Insurance in Armenia developed.

Task 4. Classroom Training and Certification of Specialized Loss Adjusters:

- Classroom training on loss adjustment guidelines and techniques for loss adjusters, insurers, financial intermediaries and AINA.
- Examination & support to AINA in the certification of loss adjusters for strong wind insurance.

Deliverable 4: Classroom Training and Certification of loss adjusters completed.

5. Modalities of Work

The selected Consulting Company will report directly to UNDP Climate Change Program Coordinator and UNDP-GCF Project Manager. The deliverables of the Consulting Company will be also overseen by the Project Management Team and AINA. In the course of the assignment, the Consulting Company will also have to work and coordinate closely with respective project partners in the priority sectors, as well as collaborate with the project team of experts and national consultants whenever required.

All deliverables should be produced in editable electronic formats. All reports shall be provided in English in pdf format; all operational documents shall be provided in Armenian in pdf and word/excel formats.

The Consulting Company will be expected to provide overall project management, quality control/quality assurance, data organization, analysis of results and final reports with oversight, guidance, and input from the Project Management Unit of UNDP.

The Consulting Company will consider the feedback of the Project Management Unit of UNDP and incorporate the necessary changes in the respective deliverables/reports.

6. Draft Timeframe of the Services

The start date for the Consultancy Services will be the date of signature of the contract between the Consulting Company and UNDP Armenia. The Services are expected to be completed within 3.5 months after contract signature according to the following tentative time schedule.

The Consulting Company should demonstrate its capability and thorough understanding of the work to be carried out, as outlined in Terms of Reference, present clear methodology for implementing the task and its ability to mobilize resources and the experts to successfully implement the works per Terms of Reference. The requirements for this contract are as follows:

- Consulting Company should be a legally registered entity, or consortium of legal entities;
- At least 3 years of proven experience in providing technical professional services related agricultural insurance considering climate change risk;
- Proven experience in successful completion of at least 1 contract of similar value, nature and complexity (for Consortium/Association, all Parties cumulatively should meet requirement)²;
