### 2. SCOPE OF WORK, RESPONSIBILITIES AND DESCRIPTION OF THE PROPOSED ANALYTICAL WORK

### 3. REQUIREMENTS FOR EXPERIENCE AND QUALIFICATIONS:

#### I. Academic Qualifications:

- A minimum of a Bachelor's degree (preferably a Master's degree) in economics, development studies, public policy, international relations or social science

## II. Years of experience:

- One year of working experience in socio-economic development and analysis;
- Relevant experience in development work at international or national level;
- Proven basic research/ analytical skills – in statistics/ econometrics; Ability to write policy papers and working documents (reports/ assessments/ reviews); and
- Decent knowledge of the Cambodian development context.

## III. Competencies:

- Good report drafting ability
- Ability to work collaboratively with team members by sharing information openly and displaying cultural awareness and sensitivity.
- Excellent communication skill is an advantage
- Positive and results-oriented attitude, able to meet targets/deadline.

## IV. Language:

- Fluency in English is required. Knowledge of Khmer is an advantage

## **4. FINANCIAL PROPOSAL**

This is a Lump sum output-based contract. Therefore, the interested offerors are requested to submit **Final All-Inclusive Price** with cost breakdown.

## **5. EVALUATION**

Offerors will be evaluated based on the Cumulative analysis.

- Technical Qualification (100 points) weight; [70%]
- Financial/Price Proposal (100 points) weight; [30%]

A two-stage procedure is utilized in evaluating the proposals, with evaluation of the technical proposal being completed prior to any price proposal being compared. Only the price proposal of the

Offerors who passed the minimum technical score of 70% of the obtainable score of 100 points in the technical qualification evaluation will be evaluated.

### 5. 1. Technical qualification evaluation criteria:

The total number of points allocated for the technical qualification component is 100. The technical qualification of the offeror/individual is evaluated based on following technical qualification:

Technical Evaluation Criteria	Obtainable Score
A minimum of a Bachelor's degree (preferably a Master's degree) in economics, development studies, public policy, international relations or social science	30
One year of working experience in socio-economic development and analysis	30
Proven basic research/ analytical skills – in statistics/ econometrics	20
A good written and oral communication skills <i>(Assessed by a sample of work)</i>	20
<b>Total Obtainable Score</b>	<b>100</b>

Only the offerors who have attained a minimum of 70% of total points will be considered as technical qualified offerors.

### 5. 2. Financial/Price Proposal Comparison:

- Only the financial/price proposal of offerors who have attained a minimum of 70% score in the technical qualification evaluation will be considered and evaluated. The total number of points allocated for the price component is 100. Below is the formula used for this evaluation:

$$\text{Rating for Financial Proposal} = (\text{Lowest Priced Offer} / \text{Price of the Offer Being Reviewed}) \times 100$$

### 5.3. Selection Method and Award Criteria:

The award of the contract should be made to the individual consultant whose offer has been evaluated and determined as:

- Responsive/compliant/acceptable, and
- Having received the highest score out of a pre-determined set of weighted technical and financial criteria specific to the solicitation. The total score for each offeror will be calculated independently by this formula: Total Score = Technical Qualification Score x 70% + Financial Score x 30%
