

## ANNEX 1: SCHEDULE OF REQUIREMENTS

### Technical Specifications

#### Summary:

The intended solution should enable the Vanuatu Department of Civil Registration and Identity Management (CRIM) to pilot a biometric registration solution that will capture a passport-size photo, fingerprints and produce a credible population registry. The solution will consist of the kit hardware needed to upgrade fixed CRIM stations to become biometric registration kits (BRK). In particular, high quality capture of face, compliant with ICAO, and fingerprints, compliant with FBI Appendix-F, as well as supporting documents will be sought.

The overall requirement of this tender exercise involves the provision of the following elements:

1. **Biometric Registration sets** made of the hardware components as defined in this Section, together with their Software Development Kit SDKs. The number of mobile BRKs to be provided is 15. UNDP may increase the quantities as per **Right to vary requirement at time of award**
2. **Warranty** for the hardware for a period of twelve (12) months. The commencement date of the twelve-month period is expected from the acceptance of the equipment.
