1. REQUIREMENTS FOR EXPERIENCE AND QUALIFICATION.

I. Academic Qualifications:

Master's degree or equivalent in social science, public policy, development studies or other equivalent relevant fields.

II. Years of experience:

- Minimum 8 (eight) years experiences in Indonesia faith-based organizations and networks
- Knowledge and relevant experiences in conduct research and analysis of community development program of faith-based fund or philanthropy
- active in faith communities is an advantage

III. Competencies and special skills requirement:

- A solid experience in the areas of economic development, policy analysis, development and planning, strategic planning of the projects focused on economic development through providing evidence-based policy advice;
- Experience in formulating development strategies and policies;
- Strong analytical, reporting and writing skills.

- Openness to change and ability to receive/integrate feedback.
- Ability to plan, organize, implement, and report on work.
- Ability to work under pressure and tight deadlines.
- Demonstrates integrity and ethical standards.
- Positive, constructive attitude to work.

2. DOCUMENTS TO BE INCLUDED WHEN SUBMITTING THE PROPOSALS.

2. FINANCIAL PROPOSAL

Lump sum contracts

The financial proposal shall specify a total lump sum amount, and payment terms around specific and measurable (qualitative and quantitative) deliverables (i.e. whether payments fall in installments or upon completion of the entire contract). Payments are based upon output, i.e. upon delivery of the services specified in the TOR. In order to assist the requesting unit in the comparison of financial proposals, the financial proposal will include a breakdown of this lump sum amount (including travel, per diems, and number of anticipated working days).

Travel;

<u>All envisaged travel costs must be included in the financial proposal</u>. This includes all travel to join duty station/repatriation travel. In general, UNDP should not accept travel costs exceeding those of an economy class ticket. Should the IC wish to travel on a higher class he/she should do so using their own resources.

In the case of unforeseeable travel, payment of travel costs including tickets, lodging and terminal expenses should be agreed upon, between the respective business unit and Individual Consultant, prior to travel and will be reimbursed
