	Α	You can check the deadline in the e-tendering websites.

	А	The stated working days is the ideal working days, but if the bidders think that 25 working days is not enough you can add the working days and it must be justified in the technical proposal.
5	Q	For scope 1 do you have any list of policy or regulation that we need to analyse to ensure that the analysis we perform are complete?
	A	Bidders can analyse policies or regulations they deemed as most relevant. Examples of relevant policies were provided in the TOR which are NDC, Presidential Regulation 98/2021, and LTS-LCCR 2050.
6	Q	How many stakeholder do the bidders need to reach for validating the inputs?
	A	Bidders can reach out to stakeholders they think as most relevant. Stakeholders have been preliminary identified in the TOR and bidders can note that key government stakeholders are Ministry of Environment and Forestry, Ministry of Energy and Mineral Resources, and Ministry of Industry.
7	Q	What is the level of data availability? e.g. specific industry data on emission by PLN, IPP, etc. Do we need to collect data to any sites?
	А	Publicly available data is deemed as the main data source for this work. Bidders can propose to use other specific data but the needed time and effort to collect such data should be carefully considered.
