## 3. REQUIREMENTS FOR EXPERIENCE AND QUALIFICATIONS:

### I. Academic Qualifications:

At least advanced university degree (master's degree) in arts, public policy, social science, development or other related field research.

### II. Years of experience:

- At least 5 years of relevant working experience in the disability inclusion and few years in social protection or scheme projects/ programs (disability/social inclusion expert is preferable).
- Experience in developing guidelines or policies related to social protection, disability pension, social insurance schemes, etc.
- Strong knowledge in national and international strategies, frameworks and policies in relation to disability inclusion, social protection, disability pension, social insurance schemes, public services support schemes, disability inclusion, and human rights.

### III. Competencies:

- Demonstrated ability to communicate effectively with government and development partners.
  - Good facilitation and presentation skills.
  - Strong interpersonal skills, ability to work with people from different backgrounds to deliver quality products within a short timeframe.
  - Be flexible and responsive to changes and demands.
  - Be client-oriented and open to feedback.
  - Displays cultural, gender, religion, race, nationality and age sensitivity and adaptability.
  - Treats all people fairly without favoritism.

#### **4. FINANCIAL PROPOSAL**

This is a Lump sum output-based contract. Therefore, the interested offerors are requested to submit **Final All-Inclusive Price** with cost breakdown

#### **5. EVALUATION**

Offerors will be evaluated based on the Cumulative analysis.

- Technical Qualification (100 points) weight; [70%]
- Financial/Price Proposal (100 points) weight; [30%]

A two-stage procedure is utilized in evaluating the proposals, with evaluation of the technical proposal being completed prior to any price proposal being compared. Only the price proposal of the Offerors who passed the minimum technical score of 70% of the obtainable score of 100 points in the technical qualification evaluation will be evaluated.

##### **5. 1. Technical qualification evaluation criteria:**

The total number of points allocated for the technical qualification component is 100. The technical qualification of the offeror/individual is evaluated based on following technical qualification:

Strong knowledge in national and international strategics, frameworks and policies in relation to disability inclusion, social protection, disability pension, social insurance schemes, public services support schemes, disability inclusion, and human rights.	20
<b>Total Obtainable Score:</b>	<b>100</b>

Only the offeror who have attained a minimum of 70% of total points will be considered as technical qualified offeror.

## **5. 2. Financial/Price Proposal Comparison:**

- Only the financial/price proposal of offeror who have attained a minimum of 70% score in the technical evaluation will be considered and evaluated.
- The total number of points allocated for the price component is 100.
- The maximum number of points will be allotted to the lowest price proposal that is opened/evaluated and compared among those technical qualified Offerors who have attained a minimum of 70% score in the technical evaluation. All other price proposals will receive points in inverse proportion to the lowest price.  $[\text{Lowest Price} \times 100 / \text{Other Price under Consideration}] = \text{Points for Other Offerors' Price Component}$ .

## **5.3. Selection Method and Award Criteria:**

The award of the contract should be made to the individual consultant whose offer has been evaluated and determined as:

- Responsive/compliant/acceptable, and
- Having received the highest score out of a pre-determined set of weighted technical and financial criteria specific to the solicitation. The total score for each offeror will be calculated independently by this formula:  $\text{Total Score} = \text{Technical Score} \times 0.7 + \text{Finance Score} \times 0.3$
