**POSITION TITLE:** Research Consultant - Study on Gender

Dynamics and Hate and Violence in Thailand

## 1) GENERAL BACKGROUND

The United Nations Development Programme (UNDP) in Thailand, in collaboration with the Royal Thai Government and partners, has implemented projects to accelerate the development of the country for more than 50 years. In line with the Country Programme Document (2022 - 2026), UNDP works with the Royal Thai Government, civil society, the private sector and the Thai public in support of the country's achievement of the SDGs.

In recent years, to promote and advance the SDGs in Thailand, especially with regard to SDG16, UNDP has adopted a "Sustaining Peace" framework which focuses on increasing tolerance and embracing diversity in view of promoting social cohesion in the country. UNDP Thailand, within the framework of a Regional Programme titled 'Preventing Violent Extremism through Promoting Tolerance and Respect for Diversity' has been partnering with the Royal Thai Government as well as non-governmental actors focusing on the following 3 key pillars:

- a. Build the capacities of key actors in view of promoting social cohesion and community resilience, tolerance and respect for diversity
- b. Strengthen knowledge management through generating reliable data, trend analysis and targeted research to inform national policy making and programming
- c. Support the development of policy frameworks which promote tolerance and diversity through a "whole of society" approach

In 2021, UNDP Thailand under the framework of regional programme on Preventing Violent Extremism conducted the Public Perception Survey on Social Cohesion and Resilience to Violent Extremism. The finding shows that females and LGBTI score higher for characteristics associated with resilience to violent extremism than males. However, non-binary gender scores lower than other genders in trust and confidence in dealing with government authorities. A better understanding of gender dimensions in hate and violent extremism is required for a better effective prevention mechanism in Thailand.

The purpose of the consultancy is to conduct research to explore the gender dimension of extremism, including women's strategic role in spreading and strengthening tolerance and vice versa in Thailand.

#### 2) OBJECTIVES OF THE ASSIGNMENT

UNDP is seeking a national consultant to conduct research on the roles of gender in PVE. The objectives of the research are as the followings:

- 1. Understanding how gender dynamics influence risk and vulnerability factors towards violence or violent extremism or vice-versa in different parts of Thailand including online landscape.
  - Differences between roles and experiences of men, women and LGBTI.
  - People's vulnerability and resilience to push and pull factors due to gender roles.
  - Differences in people's experience of the consequences of VE in a community due to their gender.
- 2. Understanding how each gender interprets and responds differently to various hate and violent extremism phenomena and the contexts involved.
- 3. Identifying key risk factors and preventive factors for each gender to hate and violent extremism based on different types of experiences and perceptions of different genders about risk and vulnerability factors depending on age, class, backgrounds, life experience, disability or educational level.
- 4. Identifying potential roles of women and other genders in countering and preventing hate and violent extremism including women in politics.
- 5. Gender mainstreaming in current policies related to PVE and their implications and limitations
- 6. Recommendations for gender-integrated approach in PVE for Thailand.

#### 3) SCOPE OF WORK

Under the supervision of the Project Manager, the consultant will deliver the following tasks:

- Develop a research plan outlining the research design, questions, methodology (with gender analysis framework) and work plan
- Review data from available sources and analysis of online hate and violent sources
- Conduct key informant interviews and focus groups
- Present preliminary results and outline of the research report
- Present research findings and recommendations for gender-integrated PVE to related academic groups, civil society organizations, relevant networks and partners to support the gender-integrated PVE policy and programmatic interventions in Thailand
- Perform other relevant tasks as necessary.

The consultant will work under the supervision of the Project Manager – Promoting Tolerance and Respect for Diversity, UNDP Thailand and in close collaboration with UNDP Programme and Technical Support Team, UNDP Regional Office colleagues and Gender Advisor. UNDP will be sharing documents based on UNDP's PVE past work and the report

from the Public Perception Survey on Social Cohesion and Resilience to Violent Extremism with the consultant.

UNDP Thailand will review the progress and quality of outputs prior to the issuance of payment. Review/ approval time required to review/ approve outputs prior to authorizing payments is 7 - 10 days.

- Excellent organizational skills with a successful track record of planning and implementing events and trainings;
- Excellent interpersonal skills; culturally and socially sensitive; ability to work inclusively and collaboratively with a range of partners, including grassroots community members, religious and youth organizations, and authorities at different levels within the Country;
- Ability to work and adapt professionally and effectively in a challenging environment;
- Ability to work effectively in a multicultural team of international and national personnel; and;
- Self-motivated, ability to work with minimum supervision; ability to work with tight deadlines.

# 11) CRITERIA FOR SELECTION OF THE BEST OFFER

Individual consultant will be evaluated based on the following methodology.

# **Cumulative analysis**

The award of the contract shall be made to the individual consultant whose offer has been evaluated and determined as a) responsive/compliant/acceptable; and b) having received the highest score out of set of weighted technical criteria (70%). and financial criteria (30%). Financial score shall be computed as a ratio of the proposal being evaluated and the lowest priced proposal received by UNDP for the assignment.

# **Technical Criteria for Evaluation (Maximum 70 points)**

Criteria 1: Relevance of Education – Max 10 points

Minimum Master's degree or equivalent in social sciences, political sciences, peace and conflict, international development, international relations, psychology, anthropology, economics, statistics or related field.

Criteria 2: Relevance of Expertise - Max 30 Points

Proven skills in qualitative and quantitative research related to gender and/ or conflict (number of research documents/publications in English and Thai);

Criteria 3: Relevance of Experience - Max 30 Points

Number of years of experience in qualitative and quantitative research methods, tools, and research report writing, working with a variety of stakeholders and partners related to gender equality and women's empowerment, programme monitoring and evaluation on peace and conflict, experience in gender analysis, gender research, gender integrated approaches to development, and/or Preventing Violent Extremism (PVE) in Thailand

Only candidates obtaining a minimum of 70% of the total technical points would be considered for the Financial Evaluation.
