

UNDP wishes the bidders to adhere to the timetable and schedule mentioned in the RFP (TOR Deliverables table) while preparing their proposals. In case of any delay in the contract award, the schedule shall be adjusted before the contract's award without changing the contract's total duration and the number of working days mentioned for each deliverable.
2	Provided that the bidders will have to find qualified individuals locally, it would be better if the timeline could be extended further.	UNDP considered the bidders' request and extended the Bid Submission deadline for another 2 (two) weeks, i.e., 17 October 2022, 5 PM. Other terms and conditions of the bid will remain unchanged .
		UNDP shall post an amendment to this effect and distribute it accordingly.
3	How much work have you done in this area previously, or is it the first of its kind?	UNDP initiated its peacebuilding programme in the Highlands last year.
