## BACKGROUND

CIWP is an intervention to alleviate and resolve threats and issues endangering wetlands in Iran through smart and innovative solutions. The Project set off its mission as a joint effort by the Department of Environment (DoE), the United Nations Development Programme (UNDP), and the Global Environmental Facility (GEF) in 2005, known as Phase I. Initially and during Phase I, the project objective was to systematically remove or substantially mitigate threats facing globally significant biodiversity of its demonstration sites, while ensuring that the lessons learned through these demonstrations are absorbed within wetland protected area management systems throughout Iran and most notably at a set of target replication sites. After the successful completion of Phase I in 2013, DoE and UNDP started a scale-up phase, i.e., Phase II, to sustain the achievements of CIWP throughout the country, ensuring that its outcomes are systematically scaled up both vertically and horizontally throughout the country.

Shortly after this fresh start, and with the financial contribution from the Government of Japan, a new component known as “Modelling Local Community Participation in Restoration of Lake Urmia through Establishment of Sustainable Agriculture and Biodiversity Conservation” was added to CIWP in 2014 that continued for seven phases until September 2021 (shortly, phases I to VII of the Lake Urmia Project).

Currently, in Phase III (2022-2025), CIWP builds on the successes of the previous phases of the Project since 2005, during which the ecosystem-based management approach was introduced and partly implemented for several wetlands. Valuable achievements of the Project during previous phases include the preparation of integrated management plans (MPs) for wetlands and establishment of the implementation structures, strengthening the wetland-related legislation, laws, and capacities at the national level, and awareness raising of the stakeholders and the public on the values of the wetlands. This will contribute to mainstreaming and replicating the Project’s model in other Iranian wetlands and sustainable wetland management and use through a participatory approach using innovative tools.

## 1. SCOPE OF WORK, RESPONSIBILITIES AND DESCRIPTION OF THE PROPOSED ANALYTICAL WORK

The International Consultant for Ecohydrology (ICEH) will develop a guideline/framework containing methods, tools, and techniques to be used for investigating threats and problems facing Iranian wetlands and introduce ecohydrological solutions. These solutions should be based on a deep understanding of hydrological and ecological factors playing a role in the sound functioning of the country’s wetlands. The solutions should be less costly and applicable to various wetlands and be included in the CIWP’s Advocacy Plan and Knowledge Package for the handover of the Project’s achievements to the relevant government stakeholders as a part of the Project’s Sustainability Strategy.

## 2. REQUIREMENTS FOR EXPERIENCE AND QUALIFICATIONS

The Consultant is required to have the following eligibility criteria:

- (ii) Provide a brief methodology on how the applicant will approach and conduct the work.

#### 2. Financial proposal

The financial proposal should be submitted in accordance with the Financial Proposal Template attached hereto as Annex IV.

#### 3. Personal CV including past experience in similar projects and at least two references.

### 5. FINANCIAL PROPOSAL

#### • **Lump sum contracts**

The financial proposal shall specify a total lump sum amount, and payment terms around specific and measurable (qualitative and quantitative) deliverables (i.e. whether payments fall in instalments or upon completion of the entire contract). Payments are based upon output, i.e. upon delivery of the services specified in the TOR. In order to assist the requesting unit in the comparison of financial proposals, the financial proposal will include a breakdown of this lump sum amount (including travel, per diems, and number of anticipated working days).

#### • **Travel;**

All envisaged travel costs must be included in the financial proposal. This includes all travel to join duty station/repatriation travel. In general, UNDP should not accept travel costs exceeding those of an economy class ticket. Should the IC wish to travel on a higher class he/she should do so using their own resources.

In the case of unforeseeable travel, payment of travel costs including tickets, lodging and terminal expenses should be agreed upon, between the respective business unit and Individual Consultant, prior to travel and will be reimbursed.

### 6. EVALUATION

  - Methodology and action plan 30%
  - Interview 40%

Only if the candidate obtains a minimum of 70% of technical score (490 out of 700 point) in technical evaluation would be considered for the Financial Evaluation.

### Terms of Reference (TOR) International Consultant for Wetland Ecohydrology

#### **Background:**

Conservation of Iranian Wetland Project (CIWP) is an intervention to alleviate and resolve threats and issues endangering wetlands in Iran through smart and innovative solutions. The Project set off its mission as a joint effort by the Department of Environment (DoE), the United Nations Development Programme (UNDP), and the Global Environmental Facility (GEF) in 2005, known as Phase I. Initially and during Phase I, the project objective was to systematically remove or substantially mitigate threats facing globally significant biodiversity of its demonstration sites, while ensuring that the lessons learned through these demonstrations are absorbed within wetland protected area management systems throughout Iran and most notably at a set of target replication sites. After the successful completion of Phase I in 2013, DoE and UNDP started a scale-up phase, i.e., Phase II, to sustain the achievements of CIWP throughout the country, ensuring that its outcomes are systematically scaled up both vertically and horizontally throughout the country.

Besides, upon the remarkable achievements of phases I to VII of the LU Project, the joint Project with the Gov. of Japan was extended for three more years to sustain the project achievements in Lake Urmia Basin and replicate the experience in two other wetland sites of the country, including Bakhtegan wetland in Fars Province and Shadegan wetland in Khuzestan provinces.

Besides the above measures, CIWP tries to take advantage of ecohydrology science to establish the relationship between hydrological processes and biotic dynamics at the basin scale. The ecohydrology concept is agreed to solve water-related problems in the world. It is included in one of UNESCO IHP VIII themes to support Sustainable Development Goals (SDGs) achievement. Hence, the framework of ecohydrology should be determined in the country to identify the linkage between water quality and quantity issues. Using ecosystem properties as a management tool enhances the carrying capacity of ecosystems against human impact. By introducing and applying this approach in the country, the relationship between hydrological processes and biotic dynamics at catchment scale will be quantified, which is supported by a profound knowledge of ecosystems’ functioning as a basis for twinning the interplay between hydrologic and ecological factors in order to increase ecosystems’ robustness.

### **Duration of work:**

### **Detailed Responsibilities:**

The consultant is responsible for conducting the following activities to achieve the expected outputs:

- Develop a guideline/framework for investigating threats and problems facing Iranian wetlands and introduce ecohydrological solutions. The guideline/framework should:
  - Define the share of CIWP's water management intervention in the health and functioning of wetland ecosystems (water quality and quantity, reducing water contamination, eutrophication, etc.);
  - Contain a monitoring programme with methodology, a set of tools and techniques, parameters, and indicators for monitoring water quantity and quality and environmental health of the Iranian wetlands;
  - Contain methodology, a set of tools and techniques, parameters, and indicators to identify the collective impact of climate change and anthropogenic activities on wetland health;
- Develop an ecohydrology knowledge package for inclusion in CIWP's Knowledge Package;
- Develop a manual of Training of Trainers (ToT) and provide training on the essential concepts and principles of ecohydrology to the Project's stakeholders and decision-makers (including the introduction of best practices from similar regions);
- Identify national and international ecohydrology networks for visibility and knowledge-sharing purposes and establish cooperation mechanisms for at least two operational networks (one international and one national);

- The contract's total payment is expected to cover cost of travel, communication, typing and preparing the soft and hard copies of documents and any other relevant costs regarding this activity.
- Upon receiving and verification of deliverables, payments will be transferred by UNDP to the account number of the consultant introduced through the signed vendor form, bank certificate and copy of passport/ID card.
- Payments will be made according to UNDP regulations as explained in the contract documents.
- Each payment will be made in EUR within 30 days from receipt of UNDP's verification and payment request.
- The consultant shall not do any work, provide any equipment, materials and supplies or perform any other services which may result in any cost in excess of the abovementioned amount.

- In case of unforeseen travel, the travel costs including tickets, accommodation and living allowances should be agreed upon, between UNDP and Individual Contractor, prior to travel and will be reimbursed by UNDP according to UNDP's rules and regulations. UNDP should not accept travel costs exceeding those of an economy class ticket. Should the contractor wish to travel on a higher class he/she should do so using their own resources.
- The cost of each travel (Ticket, Insurance, Visa, Living Allowance and Terminal fees) shall be included in the Financial Proposal and is payable only upon submission of UNDP's Travel claim form (F10), boarding passes and invoices of actual costs incurred. The cost of living allowances as per today rate has been added in the financial proposal form, however the payment of living allowance is made based on the DSA rate of date of travel. The individual offeror should consider the prevailing price for an economy class ticket serving the most direct routes in his /her financial proposal. Individual contractor wishing to upgrade his/her travel to business or first class shall do so at his/her own expense.
- During the missions to Iran, in case domestic trip is required, UNDP is responsible for purchasing the domestic tickets if needed.
- The DSA rate of Tehran will be considered for the total duration of missions however if there is a need for field visit, the DSA amount will be remunerated based on the location.

### **Travel Requirements:**

If travel is required under the contract, the individual contractor shall:

- Obtain the required Security Clearance from UNDP office (the details of travel including date of departure and arrival, accommodation and purpose of travel shall be submitted to UNDP office 2 working days before date of travel);
- Submit the certificate of BSAFE to UNDP a week before travel.. The link to access the course is <https://training.dss.un.org/course/category/6>;
- Undertake a full medical examination including x-rays and obtain medical clearance from an UN- approved physician. This is only applicable for the Consultant on the age of 65 years or more. The cost of examination shall be included in the Financial proposal;
- all ICs who will be hired during the COVID-19 Pandemic period are required to submit "Statement of Good Health" based on the WHO information on the impact of COVID-19 on individuals with underlining conditions before their travel;
- The Contractor shall consult with the delegated authorities on the bases on Travel requirements before date of departure and arrival and inform UNDP accordingly.

## Annex II GENERAL CONDITIONS OF CONTRACTS FOR THE SERVICE OF INDIVIDUAL CONTRACTORS

**1. LEGAL STATUS:** The Individual contractor shall have the legal status of an independent contractor vis-à-vis the United Nations Development Programme (UNDP), and shall not be regarded, for any purposes, as being either a “staff member” of UNDP, under the UN Staff Regulations and Rules, or an “official” of UNDP, for purposes of the Convention on the Privileges and Immunities of the United Nations, adopted by the General Assembly of the United Nations on 13 February 1946. Accordingly, nothing within or relating to the Contract shall establish the relationship of employer and employee, or of principal and agent, between UNDP and the Individual contractor. The officials, representatives, employees or subcontractors of UNDP and of the Individual contractor, if any, shall not be considered in any respect as being the employees or agents of the other, and UNDP and the Individual contractor shall be solely responsible for all claims arising out of or relating to their engagement of such persons or entities.

**2. STANDARDS OF CONDUCT:** In General: The Individual contractor shall neither seek nor accept instructions from any authority external to UNDP in connection with the performance of his or her obligations under the Contract. Should any authority external to UNDP seek to impose any instructions regarding the Individual contractor’s performance under the Contract, the Individual contractor shall promptly notify UNDP and shall provide all reasonable assistance required by UNDP. The Individual contractor shall not take any action in respect of his or her performance of the Contract or otherwise related to his or her obligations under the Contract that may adversely affect the interests of UNDP. The Individual contractor shall perform his or her obligations under the Contract with the fullest regard to the interests of UNDP. The Individual contractor warrants that she or he has not and shall not offer any direct or indirect benefit arising from or related to the performance of the Contract or the award thereof to any representative, official, employee or other agent of UNDP. The Individual contractor shall comply with all laws, ordinances, rules and regulations bearing upon the performance of his or her obligations under the Contract. In the performance of the Contract the Individual contractor shall comply with the standards of conduct set in the Secretary General’s Bulletin ST/SGB/2002/9 of 18 June 2002, entitled “Regulations Governing the Status, Basic Rights and Duties of Officials other than Secretariat Officials, and Expert on Mission”. The Individual contractor must comply with all security directives issued by UNDP.

**Prohibition of Sexual Exploitation and Abuse:** In the performance of the Contract, the Individual contractor shall comply with the standards of conduct set forth in the Secretary-General’s bulletin ST/SGB/2003/13 of 9 October 2003, concerning “Special measures for protection from sexual exploitation and sexual abuse”. In particular, the Individual contractor shall not engage in any conduct that would constitute sexual exploitation or sexual abuse, as defined in that bulletin.

The Individual contractor acknowledges and agrees that any breach of any of the provisions hereof shall constitute a breach of an essential term of the Contract, and, in addition to any other legal rights or remedies available to any person, shall give rise to grounds for suspension or termination of the Contract. In addition, nothing herein shall limit the right of UNDP to refer any alleged breach of the foregoing standards of conduct or any other terms of the Contract to the relevant national authorities for appropriate legal action.

**3. TITLE RIGHTS, COPYRIGHTS, PATENTS AND OTHER PROPRIETARY RIGHTS:** Title to any equipment and supplies that may be furnished by UNDP to the Individual contractor for the performance of any obligations under the Contract shall rest with UNDP, and any such equipment and supplies shall be returned to UNDP at the conclusion of the Contract or when no longer needed by the

Individual contractor. Such equipment and supplies, when returned to UNDP, shall be in the same condition as when delivered to the Individual contractor, subject to normal wear and tear, and the Individual contractor shall be liable to compensate UNDP for any damage or degradation of the equipment and supplies that is beyond normal wear and tear.

UNDP shall be entitled to all intellectual property and other proprietary rights, including, but not limited to, patents, copyrights and trademarks, with regard to products, processes, inventions, ideas, know-how or documents and other materials which the Individual contractor has developed for UNDP under the Contract and which bear a direct relation to, or are produced or prepared or collected in consequence of, or during the course of, the performance of the Contract, and the Individual contractor acknowledges and agrees that such products, documents and other materials constitute works made for hire for UNDP. However, to the extent that any such intellectual property or other proprietary rights consist of any intellectual property or other proprietary rights of the Individual contractor: (a) that pre-existed the performance by the Individual contractor of his or her obligations under the Contract, or (b) that the Individual contractor may develop or acquire, or may have developed or acquired, independently of the performance of his or her obligations under the Contract, UNDP does not and shall not claim any ownership interest thereto, and the Individual contractor grants to UNDP a perpetual license to use such intellectual property or other proprietary right solely for the purposes of and in accordance with the requirements of the Contract. At the request of UNDP, the Individual contractor shall take all necessary steps, execute all necessary documents and generally assist in securing such proprietary rights and transferring or licensing them to UNDP in compliance with the requirements of the applicable law and of the Contract. Subject to the foregoing provisions, all maps, drawings, photographs, mosaics, plans, reports, estimates, recommendations, documents and all other data compiled by or received by the Individual contractor under the Contract shall be the property of UNDP, shall be made available for use or inspection by UNDP at reasonable times and in reasonable places, shall be treated as confidential and shall be delivered only to UNDP authorized officials on completion of services under the Contract.

**4. CONFIDENTIAL NATURE OF DOCUMENTS AND INFORMATION:** Information and data that are considered proprietary by either UNDP or the Individual contractor or that are delivered or disclosed by one of them ("Discloser") to the other ("Recipient") during the course of performance of the Contract, and that are designated as confidential ("Information"), shall be held in confidence and shall be handled as follows. The Recipient of such Information shall use the same care and discretion to avoid disclosure, publication or dissemination of the Discloser's Information as it uses with its own similar information that it does not wish to disclose, publish or disseminate, and the Recipient may otherwise use the Discloser's Information solely for the purpose for which it was disclosed. The Recipient may disclose confidential Information to any other party with the Discloser's prior written consent, as well as to the Recipient's officials, representatives, employees, subcontractors and agents who have a need to know such confidential Information solely for purposes of performing obligations under the Contract. Subject to and without any waiver of the privileges and immunities of UNDP, the Individual contractor may disclose Information to the extent required by law, *provided that* the Individual contractor will give UNDP sufficient prior notice of a request for the disclosure of Information in order to allow UNDP to have a reasonable opportunity to take protective measures or such other action as may be appropriate before any such disclosure is made. UNDP may disclose Information to the extent required pursuant to the Charter of the United Nations, resolutions or regulations of the General Assembly or its other governing bodies, or rules promulgated by the Secretary-General. The Recipient shall not be precluded from disclosing Information that is obtained by the Recipient from a third party without restriction, is disclosed by the Discloser to a third party without any obligation of confidentiality, is previously known by the Recipient, or at any time is developed by the Recipient completely independently of any disclosures hereunder. These obligations and restrictions of confidentiality shall be effective during the term of the Contract, including any extension thereof, and, unless otherwise provided in the Contract, shall remain effective following any

termination of the Contract. Notwithstanding the foregoing, the Individual contractor acknowledges that UNDP may, in its sole discretion, disclose the purpose, type, scope, duration and value of the Contract, the name of the Individual contractor, and any relevant information related to the award of the Contract.

**5. TRAVEL, MEDICAL CLEARANCE AND SERVICE INCURRED DEATH, INJURY OR ILLNESS:** If the Individual contractor is required by UNDP to travel beyond commuting distance from the Individual contractor's usual place of residence, and upon prior written agreement, such travel shall be at the expense of UNDP. Such travel shall be at economy fare when by air.

No modification or change in the Contract shall be valid and enforceable against UNDP unless provided by means of a valid written amendment to the Contract signed by the Individual contractor and an authorized official or appropriate contracting authority of UNDP.

**7. SUBCONTRACTORS:** In the event that the Individual contractor requires the services of subcontractors to perform any obligations under the Contract, the Individual contractor shall obtain the prior written approval of UNDP for any such subcontractors. UNDP may, in its sole discretion, reject any proposed subcontractor or require such subcontractor's removal without having to give any justification therefore, and such rejection shall not entitle the Individual contractor to claim any delays in the performance, or to assert any excuses for the non-performance, of any of his or her obligations under the Contract. The Individual contractor shall be solely responsible for all services and obligations performed by his or her subcontractors. **8. **9. *Force majeure* as used herein means any unforeseeable and irresistible act of nature, any act of war (whether declared or not), invasion, revolution, insurrection, or any other acts of a similar nature or force, *provided that* such acts arise from causes beyond the control and without the fault or negligence of the Individual contractor. The Individual contractor acknowledges and agrees that, with respect to any obligations under the Contract that the Individual contractor must perform in or for any areas in

which UNDP is engaged in, preparing to engage in, or disengaging from any peacekeeping, humanitarian or similar operations, any delay or failure to perform such obligations arising from or relating to harsh conditions within such areas or to any incidents of civil unrest occurring in such areas shall not, in and of itself, constitute *force majeure* under the Contract.

**13. TERMINATION:** Either party may terminate the Contract, in whole or in part, upon giving written notice to the other party. The period of notice shall be five (5) days in the case of contracts for a total period of less than two (2) months and fourteen (14) days in the case of contracts for a longer period. The initiation of conciliation or arbitral proceedings, as provided below, shall not be deemed to be a “cause” for or otherwise to be in itself a termination of the Contract. In the event any governmental authority refuses to recognize the exemptions of the United Nations from such taxes, restrictions, duties or charges, the Individual contractor shall immediately consult with UNDP to determine a mutually acceptable procedure. UNDP shall have no liability for taxes, duties or

**16. AUDITS AND INVESTIGATIONS:** Each invoice paid by UNDP shall be subject to a post-payment audit by auditors, whether internal or external, of UNDP or by other authorized and qualified agents of UNDP. The Individual contractor acknowledges and agrees that UNDP may conduct investigations relating to any aspect of the Contract or the award thereof, and the obligations performed thereunder.

## **17. SETTLEMENT OF DISPUTES:**

Where the parties wish to seek such an amicable settlement through conciliation, the conciliation shall take place in accordance with the Conciliation Rules then obtaining of the United Nations Commission on International Trade Law ("UNCITRAL"), or according to such other procedure as may be agreed between the parties in writing.

**ARBITRATION:** Any dispute, controversy or claim between the parties arising out of the Contract, or the breach, termination, or invalidity thereof, unless settled amicably, as provided above, shall be referred by either of the parties to arbitration in accordance with the UNCITRAL Arbitration Rules then obtaining. The decisions of the arbitral tribunal shall be based on general principles of international commercial law. For all evidentiary questions, the arbitral tribunal shall be guided by the Supplementary Rules Governing the Presentation and Reception of Evidence in International Commercial Arbitration of the International Bar Association, 28 May 1983 edition. The arbitral tribunal shall be empowered to order the return or destruction of goods or any property, whether tangible or intangible, or of any confidential information provided under the Contract, order the termination of the Contract, or order that any other protective measures be taken with respect to the goods, services or any other property, whether tangible or intangible, or of any confidential information provided under the Contract, as appropriate, all in accordance with the authority of the arbitral tribunal pursuant to Article 26 ("Interim Measures of Protection") and Article 32 ("Form and Effect of the Award") of the

UNCITRAL Arbitration Rules. The arbitral tribunal shall have no authority to award punitive damages. In addition, unless otherwise expressly provided in the Contract, the arbitral tribunal shall have no authority to award interest in excess of the London Inter-Bank Offered Rate (“LIBOR”) then prevailing, and any such interest shall be simple interest only. The parties shall be bound by any arbitration award rendered as a result of such arbitration as the final adjudication of any such dispute, controversy or claim.

**18. LIMITATION ON ACTIONS:** Except with respect to any indemnification obligations in Article 9, above, or as are otherwise set forth in the Contract, any arbitral proceedings in accordance with Article 17, above, arising out of the Contract must be commenced within three (3) years after the cause of action has accrued.

The Parties further acknowledge and agree that, for these purposes, a cause of action shall accrue when the breach actually occurs, or, in the case of latent defects, when the injured Party knew or should have known all of the essential elements of the cause of action, or in the case of a breach of warranty, when tender of delivery is made, except that, if a warranty extends to future performance of the goods or any process or system and the discovery of the breach consequently must await the time when such goods or other process or system is ready to perform in accordance with the requirements of the Contract, the cause of action accrues when such time of future performance actually begins.

**19. PRIVILEGES AND IMMUNITIES:** Nothing in or relating to the Contract shall be deemed a waiver, express or implied, of any of the privileges and immunities of the United Nations, including its subsidiary organs.
