H. Qualifications of the Successful Contractor

A company / organization duly registered in the Republic of Kazakhstan and meeting the following requirements can be the Supplier:

- 1. Be solvent, not subject to liquidation, its property should not be seized, financial and economic activities should not be suspended in accordance with the law (certificates confirming the absence of debts in tax authorities at the end of the last financial year);
- 2. At least three years of experience in supplying computer equipment.
- 3. Availability of dealer agreements with the manufacturers of computer equipment or official distributors in the territory of the Republic of Kazakhstan.
- 4. The supplier shall provide in written the confirmation of warranty on the equipment for at least one year
- 5. The vendor shall provide information on available local service and maintenance center in the Republic of Kazakhstan address, contact details in the price quotation.
