## **Access Control and CCTV systems Improvement -ToR**

### **Background**

The United Nations Development Programme (UNDP) is currently in the process of relocating its offices from the current location, 182 Mzingu Way, Oyster Bay, Dar es Salaam, to PSSSF Complex building. The building has CCTV and Access Control systems installed but some modifications/improvements are needed.

UNDP therefore seeks a vendor who can do the works on the installed CCTV and Access Control systems in the new office, as detailed in the scope below.

### **Scope of Work:**

- Add extra cameras (11 - Dome Cameras and 3 - Bullet Cameras) to blind spots identified and calibrating the existing cameras to have a better viewing angle.
- Add new server for access control so that the current system in HQ tower is delinked from the Commercial Tower.
- Add proximity readers to the lifts and program the lifts to operate by access cards only.
- Provide Training to the staff that will be responsible in managing the systems.
- Decommission of the CCTV system at old OneUN House.
- All additional works will carry 1 year warranty (workmanship)
- The access control system must allow for safe operation and emergency egress during power outages (mainly to cover the time until the backup generator kicks in).
- Maintain the ability to control access (i.e. only authorized persons can enter/leave by using their cards), but also must have emergency overrides on the emergency exits (here anyone should be able to leave, even if they have no card. This should normally trigger an alarm.)
