A two-stage procedure is utilized in evaluating the submissions, with evaluation of the technical components being completed prior to any price proposals being opened and compared. The price proposal will be opened only for submissions that passed the minimum technical score of 70% of the obtainable score of 1000 points in the evaluation of the technical component.

The technical component is evaluated on the basis of its responsiveness to the Term of Reference (TOR).

Maximum 1000 points will be given to the lowest offer and the other financial proposals will receive the points inversely proportional to their financial offers. i.e.  $Sf = 1000 \times Fm / F$ , in which Sf is the financial score, Fm is the lowest price and F the price of the submission under consideration.

The weight of technical points is 70% and financial points is 30%.

Submission obtaining the highest weighted points (technical points + financial points) will be selected.

Interview with the candidates may be held if deemed necessary.

#### 5. Contract

"Lump-sum" Individual Contract will be applied for freelance consultant (Annex II)
"Lump-sum" RLA will be applied for consultant assigned by firm/institution/organization (Annex III)

- Full medical examination and Statement of Fitness to work for consultants from and above 62 years of age and involve travel. (This is not a requirement for RLA contracts).
- Release letter in case the selected consultant is government official.

COUNTRY OF ASSIGNMENT: Viet Nam

#### 1) GENERAL BACKGROUND

Under the umbrella of the United Nations Framework Convention on Climate Change (UNFCCC) the 21st Conference of the Parties (COP 21) adopted the Paris Agreement on 12th December 2015. Although holding on to the principle of common but differentiated responsibilities and respective capabilities, the Paris Agreement establishes obligations for developed and developing countries. The different mechanisms and instruments established relate to mitigation, adaptation, loss and damage, finance, technology development and transfer, capacity building, transparency, and compliance. While some of them are mandatory for the countries, others are of facultative nature. Many of mechanisms and instruments need the development of modalities and further guidance for implementation. Since it opened for signature on 22nd April 2016, already 178 countries signed the Paris Agreement – among them Vietnam. The next step is the ratification of the Paris Agreement and the deposition of the instrument of ratification with the depositary.

For Vietnam the Paris Agreement creates opportunities such as access to more financial support and advanced technologies, but also poses challenges especially in regard to mitigation activities and provision of transparency. Building on existing – soft – obligations, the Paris Agreement intensifies requirements in regard to greenhouse gas emission reductions as well as measuring, reporting and verification. Implementing the Paris Agreement will require joint efforts from various sectors, public and private stakeholders, and different levels of administration. Therefore, guiding implementation needs to be informed and consistent. That requires creating consensus between the policy makers about the impacts of the Paris Agreement on Vietnam and the implementation needs.

The Ministry of Natural Resources and Environment (MONRE) is the state management agency responsible to oversee and manage national climate change response and has been assigned by the Government of Vietnam to function as the focal point for the participation in and implementation of the UNFCCC and now the Paris Agreement. Under MONRE the Department of Meteorology, Hydrology and Climate Change (DMHCC) will coordinate the ratification and implementation of the Paris Agreement. According to the Law on Treaties from 2016, ratification by the Government of Vietnam requires the submission of an implementation plan and of an impact assessment in regard to socio-economic and regulatory aspects.

Currently, DMHCC is preparing for the ratification of the Paris Agreement and is working on an action plan for implementation in cooperation with international partners. To support this process and to provide the necessary background for informed decision-making, DLA will issue a regulatory impact assessment report identifying new or amended obligations and necessary changes to policies and regulations to implement the Paris Agreement and to consult with DMHCC on the activities to be included into the action plan.

### 2) OBJECTIVES OF THE ASSIGNMENT

The objective of the assignment is to carry out a policy impacts assessment of the implementation of the Paris Agreement and the (I)NDC. The implementation of the Paris Agreement is in effect the implementation of the Viet Nam (I)NDC which cover all aspects of mitigation, adaptation, and means of implementation.

# 3) SCOPE OF WORK AND ACTIVITIES

The consultant will perform the following tasks:

- Identification and review of the relevant existing policies and regulations that relate to the activities planned to implement the Paris Agreement and the (I)NDC
- Analysis of the existing policies and regulations to assess their sufficiency to shape the activities to implement the Paris Agreement and the (I)NDC
- Development of mechanisms and instruments as a framework for the implementation activities and consultation with DLA and DMHCC on feasible options

The regulatory impact assessment to be conducted for the implementation activities for the Paris Agreement will relate to the following topics:

- 1. Mitigation
- Obligation to prepare, communicate and maintain successive (I)NDC
- Obligation to pursue domestic mitigation measures
- Advice to formulate and communicate long-term low greenhouse gas emission development strategies
- Advice to implement the (I)NDC
- Encouragement to implement REDD-plus
- Voluntary engagement in cooperative approaches using internationally transferred mitigation outcomes
- Voluntary use of the sustainable development mechanism

#### 2. Adaptation

- Obligation to engage in adaptation planning processes
- Obligation to implement adaptation actions
- Advice to submit and update periodically an adaptation communication
- Advice to implement the (I)NDC
- Advice to enhance understanding, action and support through the Warsaw International Mechanism for Loss and Damage on a cooperative and facilitative basis
- 3. Technical and Financial Support
- Aim to make finance flows consistent with a pathway towards low greenhouse gas emissions and climate resilient development
- Financial Mechanism of the Convention
- Technology Mechanism of the Convention
- Advice to cooperate to enhance capacity
- Advice to regularly communicate progress made on implementing capacity-building plans, policies, actions or measures

- 4. Transparency
- Obligation to regularly provide a national inventory report
- Obligation to regularly provide the information necessary to track progress implementing and achieving the (I)NDC
- Advice to provide information related to climate change impacts and adaptation
- Advice to provide information on financial, technology transfer and capacity-building support needed and received

# 4) DURATION OF ASSIGNMENT, DUTY STATION AND EXPECTED PLACES OF TRAVEL

In total, the assignment is estimated to be 20 working days spread over the period of July -September 2016. The work can be done from home base. Travel to Ha Noi to attend consultation workshop may be required and will be funded separately based on UN-EU Cost Norms.

# 5) FINAL PRODUCTS

Expected output is a regulatory impact assessment report that can be brought together with the socioeconomic impact assessment report and supports the action plan to implement the Paris Agreement and the (I)NDC developed by DMHCC to prepare for ratification.

The regulatory impact assessment report shall:

- Include list all potential impacts of the Paris Agreement and the (I)NDC
- Point to gaps and shortcomings in Vietnamese policies
- Include list the Vietnamese policies that need to be revised or newly adopted
- Recommend options for the revision or adoption of policies

The work plan including the tasks and the time frame shall be developed in consultation with the Department of Legal Affairs, MONRE (DLA) and UNDP.

The national consultant will submit working drafts to UNDP and DLA as input and for comments before finalizing the report for submission.

The consultant shall deliver to UNDP and DLA all draft and final documents and supporting research material and shall consult with DLA on the assessment of the regulatory impacts of the action plan to implement the Paris Agreement and mechanisms and instruments to handle the coming tasks.

#### 6) PROVISION OF MONITORING AND PROGRESS CONTROLS

The overall process will be managed by the Policy Advisory Team and the Sustainable Development in UNDP and the Department of Legal Affairs in MONRE.

#### 7) DEGREE OF EXPERTISE AND QUALIFICATIONS

The national consultant should have the following qualifications:
